SUBJECT: Approval of Resolution No. 2011-10 Authorizing the Designation of the Universal Agent for submitting applications for FEMA grant funds for the Regional Park and Open-Space District

**RECOMMENDED MOTION:** That the Board approves and authorizes Resolution No. 2011-10 designating the Regional Park and Open-Space District (District) positions to act as the Authorized Agents eligible to submit applications for federal funds to the Federal Emergency Management Agency (FEMA).

BACKGROUND: Due to natural disasters, or other emergency occurrences, FEMA may designate areas as eligible for emergency repair funding to both mitigate further deterioration as well as implementation of more permanent solutions for future prevention. During the recent storms in December 2010, the District suffered structural damages to areas that FEMA has designated as eligible for repair funding. To apply for and receive said funding, the District must designate positions as Universal Agents that are able to process paperwork on the District's behalf. The approval of Resolution No. 2011-10 will delineate the positions eligible to act as said Universal Agent for the next three fear period. At that time, renewal of the resolution will occur.
