

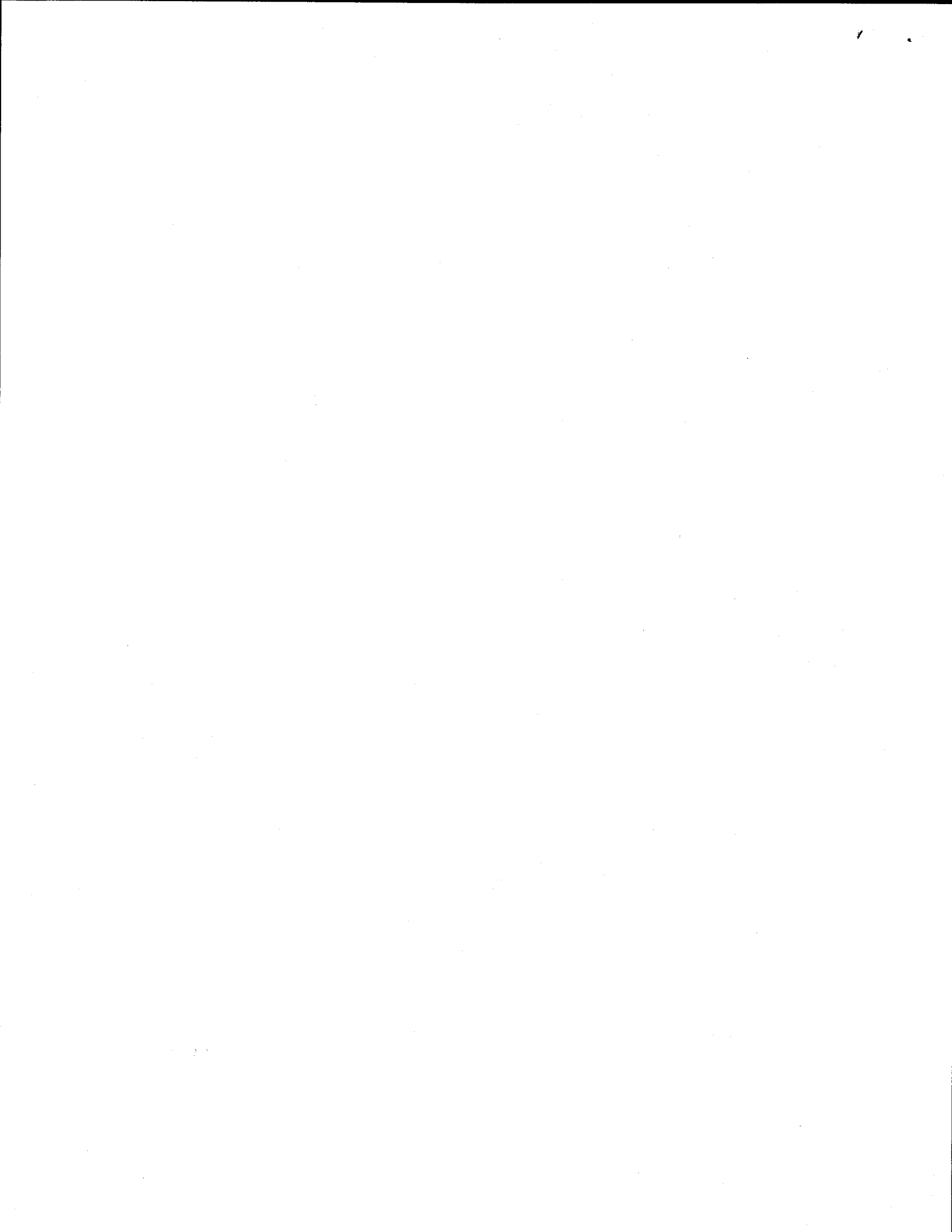
**MINUTES OF THE BOARD OF SUPERVISORS**
