BACKGROUND: By Minute Order dated March 22, 2011 (agenda item 3.28) the Board authorized the Clerk of the Board to advertise for the construction of sidewalk and street improvements on Ben Nevis Boulevard from Conning Street to 200' east of Lindsay Street, in the unincorporated community of Glen Avon. Additionally, the plans and specifications were approved by the Board within this agenda item.

During the advertisement period, one addendum was issued to all registered plan holders as a supplement to the specifications and special provisions. Bidders are required to acknowledge and to take into account addendum on their Contractor's Proposal. The addendum was issued to clarify and modify the contract documents. The addendum is attached as Addendum No. 1.

Bids for the project were opened in the office of the Director of Transportation at 2:00 PM, Wednesday, April 13, 2011. Eleven bids were received. The basis for the selection of a contractor is the lowest responsive and responsible bidder.

The lowest bid was submitted by Black Rock Construction Co. of Brea, CA in the amount of \$246,970; which is \$41,141 (14.28%) below the Engineer's Estimate.

The Transportation Improvement Program provides for the construction of sidewalk and related street improvements along Ben Nevis Boulevard from Conning Street to 200 feet east of Lindsay Street, which is a known pedestrian route for children attending Mission Bell Elementary School, located on Conning Street south of Ben Nevis Boulevard.

The bid documents included the Base Bid for roadway improvements, and Alternate bid schedule 1, to adjust manholes to grade, and Alternate bid schedule 2, to adjust water meter boxes to grade. Jurupa Community Service District (JCSD) owns the affected utility facilities, and JCSD has approved the award of the alternate bid schedules, as bid by the apparent low bidder. All costs for the work will be funded by JCSD.

The project is funded by SB 821 Local Transportation funds, and by Redevelopment Agency funds through a cooperative agreement that will be submitted to the Board of Supervisors for execution prior to, or concurrent with, the award of the construction contract. The SB 821 funds were secured through a grant for which the Transportation Department successfully competed. The project is expected to be completed within the existing budget as shown on Attachment "A".

The Contractor has executed the contract and has provided bonds and insurance certificate documents, which meet the requirements of the contract.

The contractor is qualified.

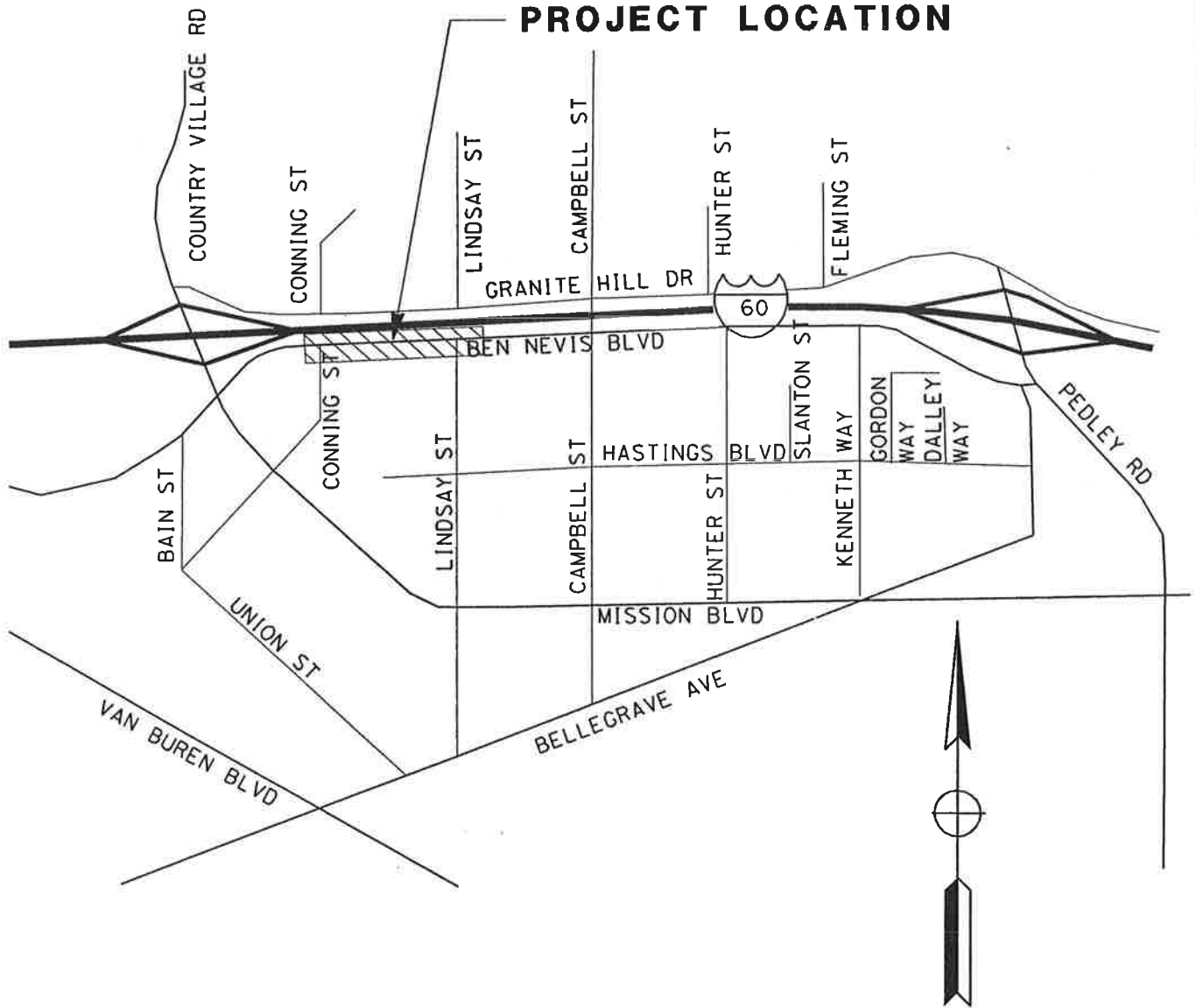
