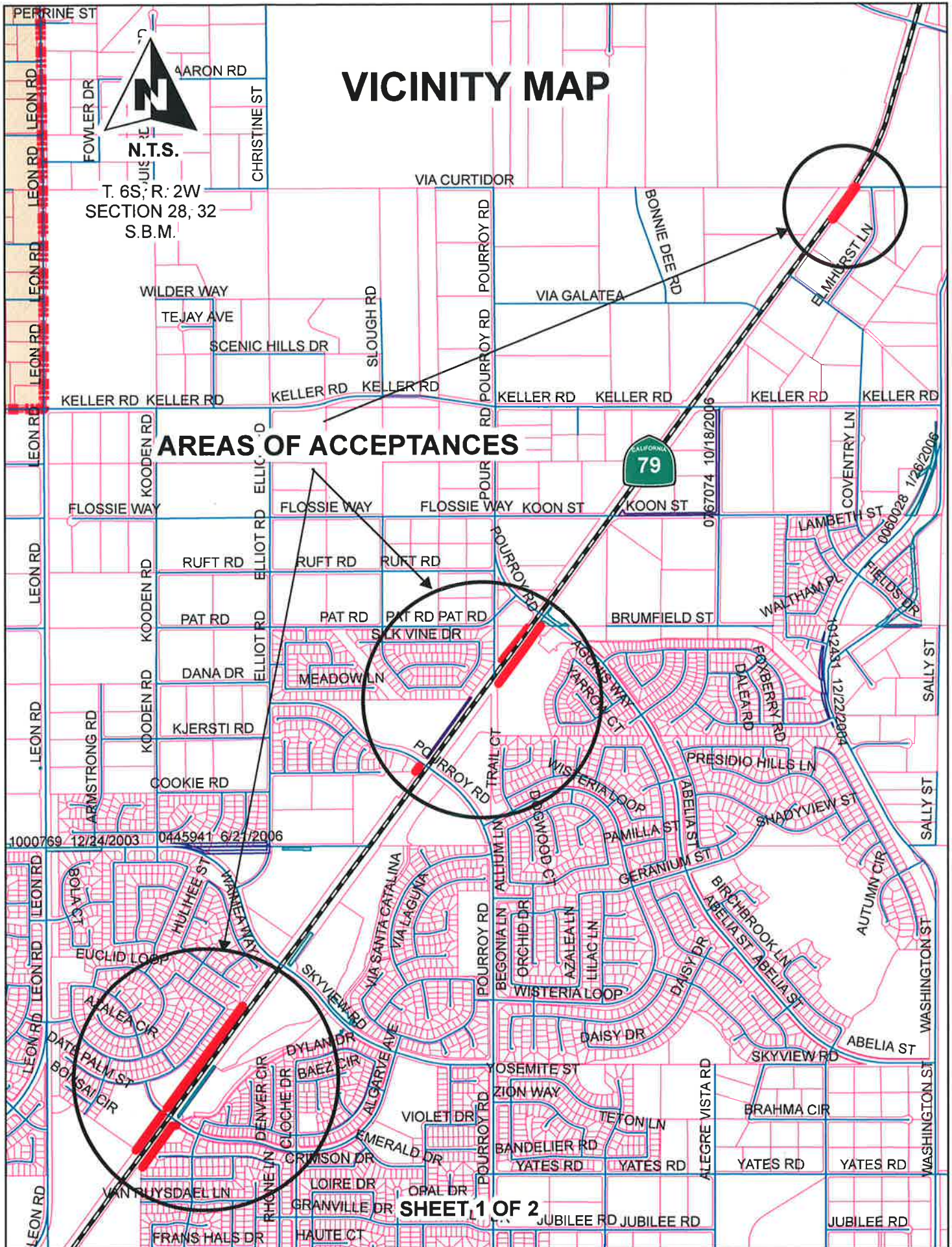
# VICINITY MAP

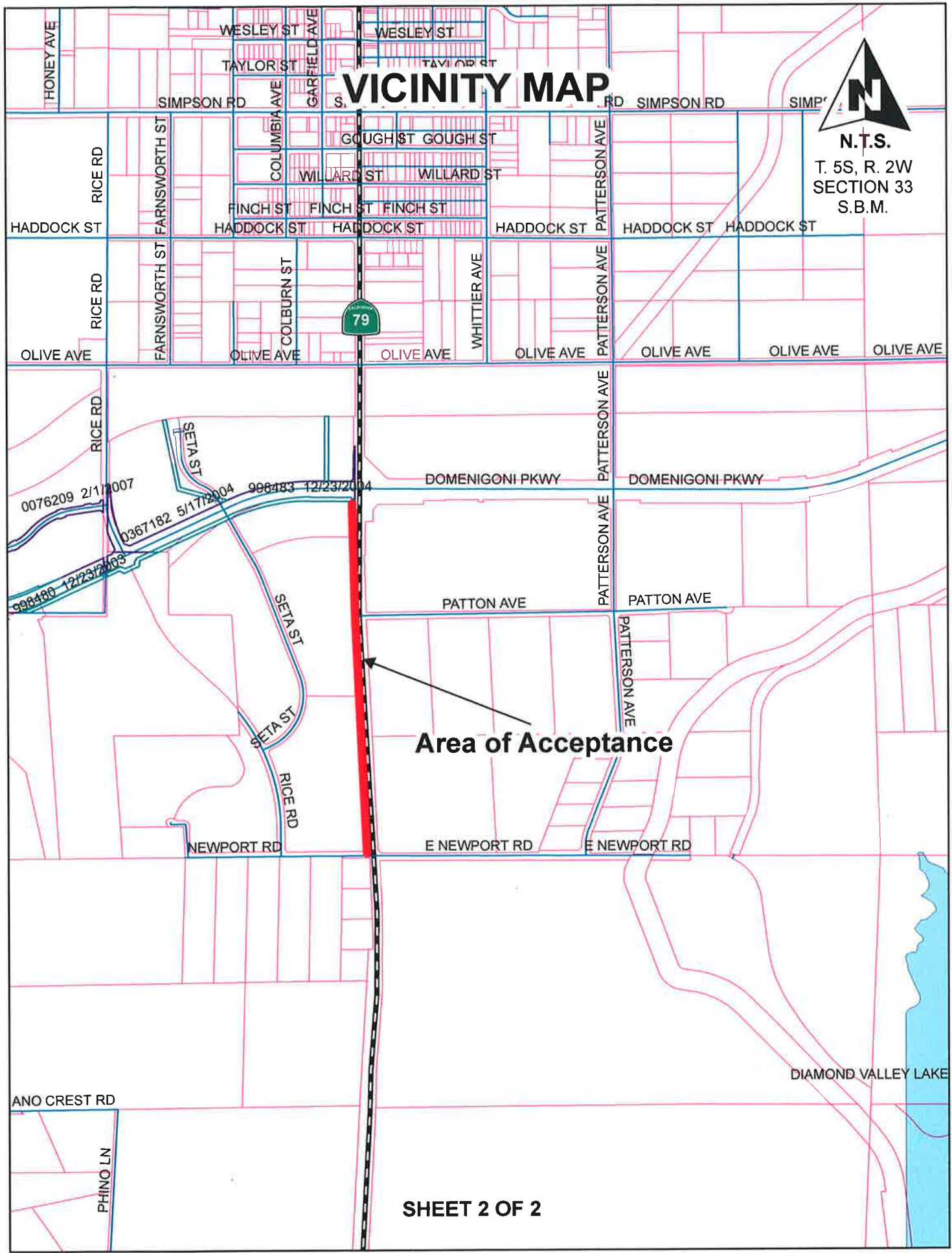

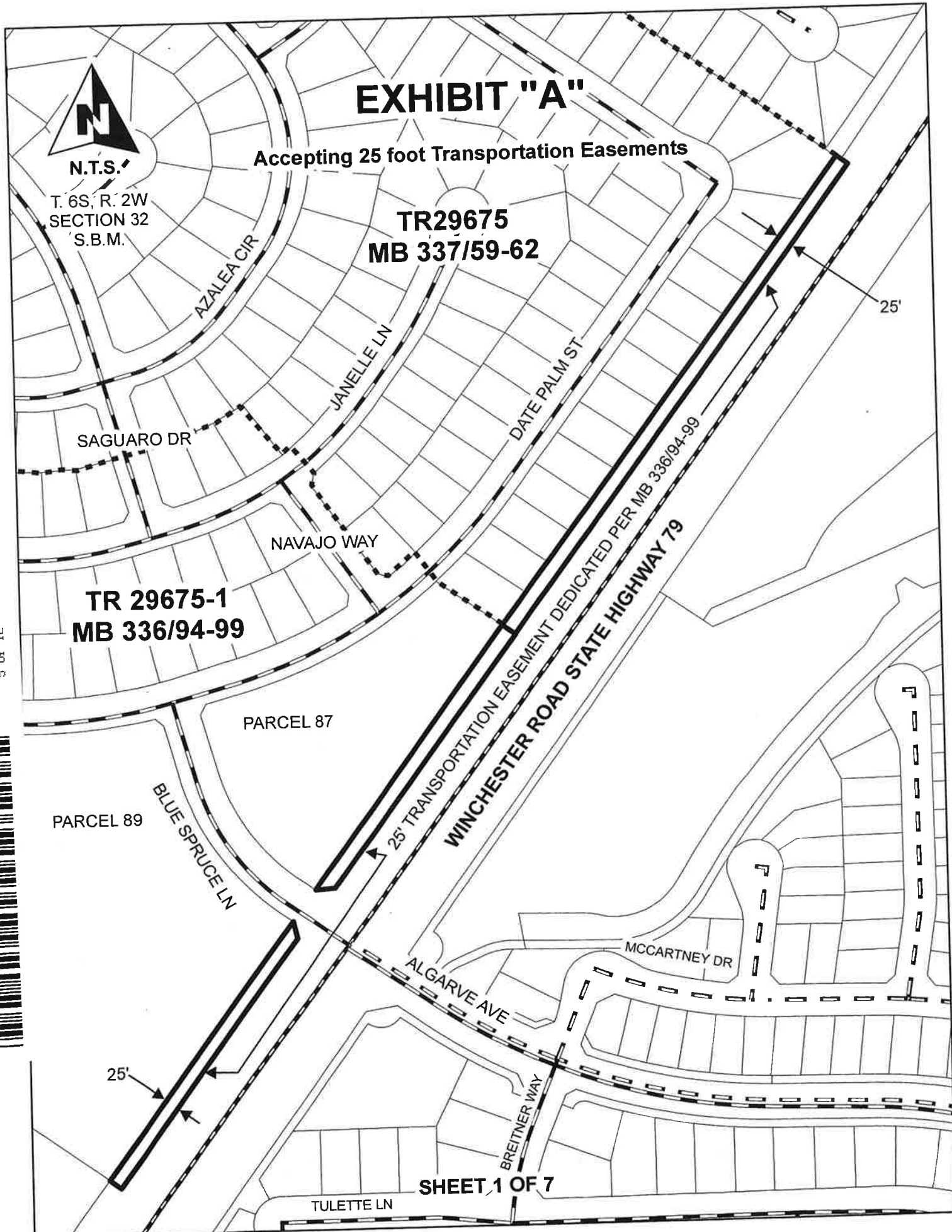

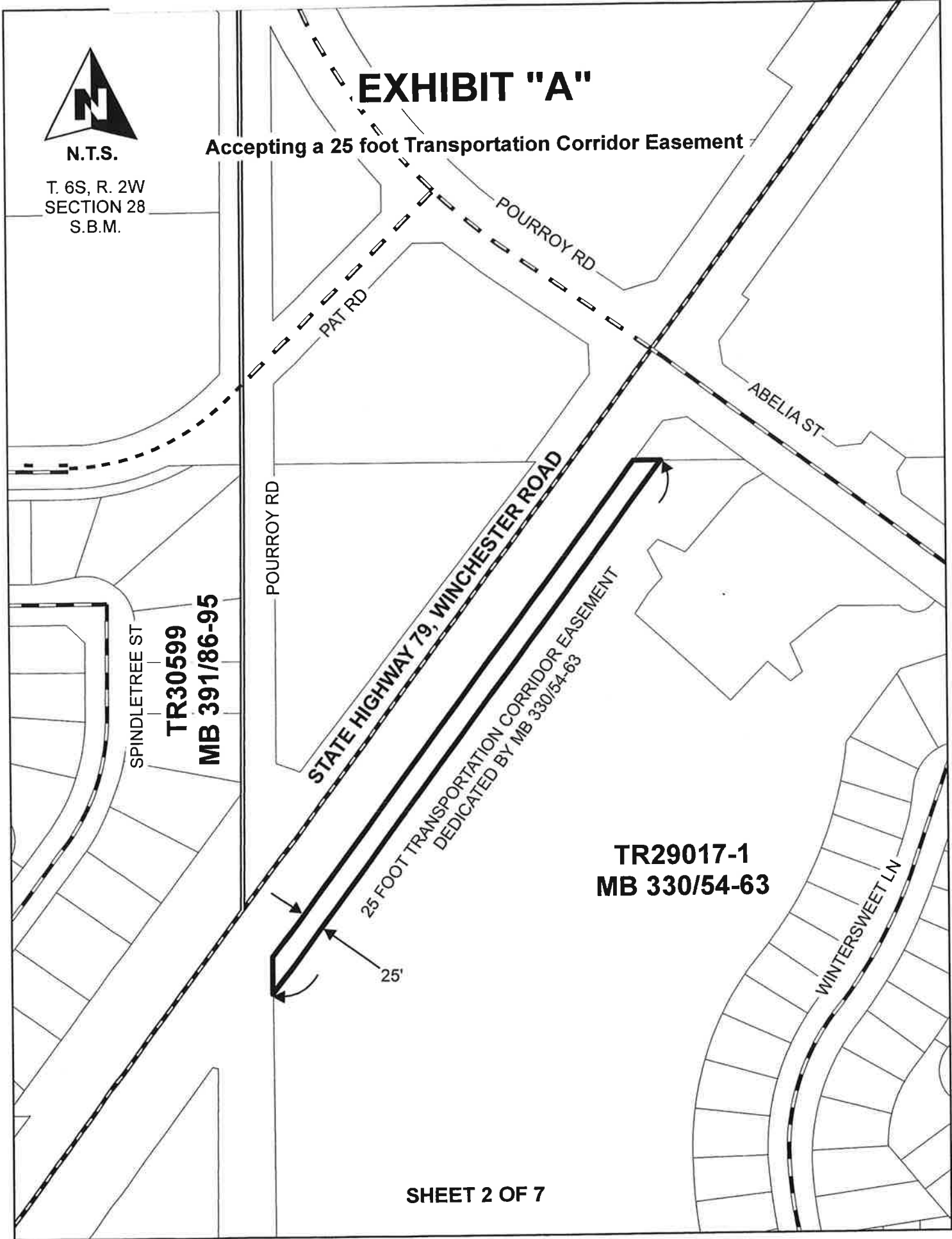
