

**SUBJECT:** FY 2011-12 Budget Adjustments for the Parks District and Human Resources - Delta Dental

**RECOMMENDED MOTION:** That the Board of Supervisors approve and direct the Auditor Controller to make adjustments, effective July 1, 2011, to estimated revenue and appropriations as shown in Attachment A.

**BACKGROUND:** During the FY 2011/12 budget process, two new funds were added to the budget entry system for management of funds for Human Resources' Delta Dental insurance plan and Parks District's California River Parkways Program (Proposition 50). The Delta Dental agreements were approved by the Board in February 2011. Costs will be paid using member contributions approved with these agreements. The California Rivers Parkways Program is funded with state grants created under the Water Security, Clean Drinking Water, Coastal and Beach Protection Act of 2002 (Proposition 50).

Due to an error within the budget system, these budgets were not included with the printed recommended budget document submitted to the Board for the June 13, 2011 Board meeting. Consequently, these budget items were not formally approved by the Board. No expenditures may be made until the Board formally approves the proposed budgets for these funds.


