**BACKGROUND (Continued)**

Employment Training Panel (ETP) is a State of California employer-supported training program that trains employees for high wage high skill jobs and retains employed workers in companies that face out-of-state competition. Since 2004 to date EDA has received Employment Training Panel funding and partnered with UCR to retain over 700 existing employees of local manufacturers.

As a result of our success, EDA submitted a proposal to retrain 150 employees. At the March 25, 2011 Employment Training Panel Meeting, EDA was awarded an additional \$69,402 for Fiscal Years 2011-2013. EDA is responsible for the administration of the agreement and will subcontract with UCR and other service providers to provide the retraining services.
