THIRD AMENDMENT TO THE JOINT USE AGREEMENT BETWEEN THE COUNTY OF RIVERSIDE AND THE HEMET UNIFIED SCHOOL DISTRICT FOR JOINT USE OF FACILITIES LOCATED AT HAMILTON HIGH SCHOOL

1. Recitals.

- a. County and District entered into that certain Agreement dated June 17, 2003, (the "Original Agreement") pursuant to which County leased a portion of that certain building located at 57430 Mitchell Road, Anza, California (the "Building"), as more particularly shown on Exhibit "A", attached hereto and made a part hereof.
 - b. The Original Agreement has been amended by:
- i. That certain First Amendment dated June 30, 2009, (the "First Amendment").
- ii. That certain Second Amendment dated July 13, 2010, (the "Second Amendment").
- c. The Original Joint Use Agreement, as heretofore, currently, or hereafter amended, shall hereafter be referred to as the "Agreement".

NOW THEREFORE, for good and valuable consideration the receipt and adequacy of which is hereby acknowledged, the parties agree as follows:

2. Capitalized Terms: Third Amendment to Prevail. Unless defined herein or the context requires otherwise, all capitalized terms herein shall have the meaning defined in the Agreement, as heretofore amended. The provisions of this Third Amendment shall prevail over any inconsistency or conflicting provisions of the

Agreement, as heretofore amended, and shall supplement the remaining provisions thereof. The Agreement remains in full force and effect except to the extent amended by this Third Amendment.

- 3. Term of the Agreement. Section A. 4.2 of the Second Amendment shall be amended as follows: The term of this Agreement shall be extended twelve (12) months commencing on July 1, 2011 and terminating on June 30, 2012.
- **4. Rent.** County shall pay to District the yearly sum as rent for the leased premises during the term of this Lease as indicated below:
