**SUBJECT:** Discharge of Accountability for Demolished or Non-County Owned Capital Assets

**RECOMMENDED MOTION:** That the Board of Supervisors approve the discharge from accountability pursuant to Government Code 24051 for demolished or non-county owned capital assets with a purchase value of \$8,899,261.

**BACKGROUND:** The Economic Development Agency (EDA) recently conducted a physical inventory of county owned buildings. During the inventory process there were several buildings identified that should be retired due to demolition or not owned by the county, as specified in Attachment "A". EDA staff has been working with the Auditor-Controller's Office (ACO) to complete these write-offs. These assets are fully depreciated and there is no financial impact.
