BACKGROUND:

Pursuant to Ordinance 659.6, the Development Impact Fee (DIF) program allows for the use of DIF funds for facilities within specific areas indentified on the Public Facilities List through the year 2010. The Eastvale Master Drainage Plan area was included on the Public Facilities Needs List.
