BACKGROUND: (Continued)

Since the service rate submittal in January of this year I have been focusing on increasing efficiencies through information technology. There are opportunities to consolidate and potentially contract for certain information technology functions as well as utilize emerging technologies to reduce operational costs. As a result I am recommending the release of certain previously designated information technology capital funds and the return of these funds to departments and the issuance of new designations for the balance of capital projects/enterprise efforts that must go forward.

The attached Table A lists the previously requested designations that were to become effective 7/1/2011. Since the initial request for these designations, some projects have been completed and therefore no further designations are needed. Table B is a revised list of designations that are needed for capital projects that are not yet completed.

The completion of projects and the reduction in designations allows for a refund to county departments. For General Fund departments, the refund will become part of fund balance to assist in eliminating the FY 10-11 budget shortfall. I am also recommending a reduction of RCIT's 60-day working capital reserve to a 30-day working capital reserve to release additional cash to partially fund the PSEC project revised budget;

In total, the reduction in designations and cash reserves will allow a \$4 million refund to departments for FY10/11 as per Attachment A. This effort has been coordinated through the Executive Office with their concurrence.
