- 3. If the owner of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, may abate the excess outside storage by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials on the real property is declared to be in violation of Riverside County Ordinance Nos. 348, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An initial inspection was made of the subject property by the Code Enforcement Officer on September 21, 2010.
- 2. The inspection revealed excess outside storage of materials on the subject property in violation of Riverside County Ordinance No. 348. The items included but were not limited to: a 10" x 10" storage shed in the amount of one hundred (100) square feet.
- 3. Subsequent follow up inspections of the above-described real property on December 8, 2010, January 12, 2011, March 9, 2011 and June 17, 2011, revealed that the property continued to be in violation of Riverside County Ordinance No. 348.
- 4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of excess outside storage.

DECLARATION OF OFFICER CAROL FORREY

[R.C.O. NO. 348, R.C.C. Title 17]

- I, Carol Forrey, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereto under oath:
- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On September 21, 2010, I conducted an initial inspection of the real property described as 1 Parcel East of 52993 Manzanita, Idyllwild, Riverside County, California and further described as APN 560-031-012 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by SNF Properties, LLC (hereinafter referred as "OWNER"). Certified copies of the County Equalized Assessment Roll for the year 2010-2011 and County Geographic Information System ("GIS") report is attached hereto as Exhibit "B." THE PROPERTY is located within the R-1A (One Family Dwelling, Mountain Resort Zone) zone classification. This zone classification allows outside storage on an improved parcel with the amount of storage to be one hundred (100) square feet for properties that are a minimum of one-half acre in size. THE PROPERTY is unimproved and approximately .26 acres and therefore, no amount of storage is allowed.
- A copy of a report generated from the Based upon the Lot Book Reports issued by RZ 4. Title Company dated October 13, 2010 and updated on March 23, 2011, it is determined that no other parties potentially hold a legal interest in THE PROPERTY. True and correct copies of the Lot Book Reports are attached hereto and incorporated herein as Exhibit "C."

- 5. On September 21, 2010, I drove to THE PROPERTY to conduct an inspection. THE PROPERTY was open, vacant, and accessible and I could clearly see a 10" x 10" storage shed on the parcel. As a result of the outside storage, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") No. 348, as codified in Riverside County Code ("RCC") Title 17. I posted a Notice of Violation on THE PROPERTY with an address closest to the parcel. All other Notices referred to the address 2 Parcels away from THE PROPERTY.
- 6. On September 22, 2010, October 29, 2010 and January 26, 2011, a Notice of Violation was mailed to the OWNER by certified mail, return receipt requested.
- 7. On December 8, 2010, January 12, 2011 and March 9, 2011, I conducted follow-up inspections of the open and accessible property. I observed that THE PROPERTY remained in violation of RCO 348 (RCC Title 17).
- 8. A site plan and photographs of the condition of THE PROPERTY are attached hereto as Exhibit "D" and are incorporated herein by reference.
- 9. True and correct copies of each Notice issued in this matter and other documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- 10. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 11. I am informed and believe and based upon said information and belief alleges that the OWNER does not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- 12. A Notice of Non-Compliance was recorded in the Office of the County Recorder, County of Riverside, State of California, on November 5, 2010 as Instrument Number 2010-0534057, a true and correct copy of which is attached hereto and incorporated herein by reference as Exhibit "F".
- 13. On June 17, 2011 I conducted another inspection of THE PROPERTY which revealed that THE PROPERTY remained in violation of RCO 348 (RCC Title 17).
- 14. On June 8, 2011, the second notice "Notice to Abate Public Nuisance" providing notification of the Board hearing scheduled for June 28, 2011, as required by Riverside County Ordinance

No. 725, was mailed to OWNER by certified mail, return receipt requested and on June 17, 2011, was posted on THE PROPERTY. True and correct copies of the notice, returned receipt cards, together with the proof of service, and the affidavit of posting of notices are attached hereto as Exhibit "G" and are incorporated herein by reference.

- 15. The removal of all outside storage of materials currently on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside County Ordinance Nos. 348 and the <u>Health</u> and Safety Code.
 - 16. Accordingly, the following findings and conclusions are recommended:
 - (a) the outside storage of materials on THE PROPERTY be deemed and declared a public nuisance;
 - (b) the OWNER or whoever has possession or control of THE PROPERTY be required to remove all storage of materials on THE PROPERTY in accordance with the provisions of County Ordinance No. 348.
 - (c) that if the materials are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 348, within ninety (90) days of the date of this Order, the outside storage of materials may be abated by representatives of the Riverside County Department of Building and Safety, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.


(d) that reasonable costs of abatement, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 348 and 725.


CForrey / Shed still on property - 12/08/2010


