SUBJECT: Allocation of Development Impact Fee Funds

RECOMMENDED MOTION:

- 1. Authorize the commitment of \$900,117 in Development Impact Fees from the Eastvale Area Plan Flood Control Facility Fund (Fund 30537) for costs associated with projects within the Eastvale Master Drainage Plan area.
2. Direct the Executive Office to transfer up to \$900,117 of Development Impact Fees from the Eastvale Area Plan Flood Control Facility Fund (Fund 30537) to the Flood Control and Water Conservation District as needed, pursuant to contracts and billings received for the Eastvale Master Drainage Plan Line E and other related projects within the Eastvale Master Drainage Plan area.

BACKGROUND:

Pursuant to Ordinance 659.6, the Development Impact Fee (DIF) program allows for the use of DIF funds for facilities within specific areas identified on the Public Facilities List through the year 2010. The Eastvale Master Drainage Plan area was included on the Public Facilities Needs List.
