BACKGROUND: On January 25, 2011, the County of Riverside entered into a contract with Southwest Construction for the Apron Rehabilitation at the Hemet-Ryan Airport. The project consisted of applying the asphalt rejuvenating seal to tie-down and apron areas, and reapplying airfield makings. The project was completed on June 3, 2011 and the airport has been returned to its full operational capacity.
