BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 704 (RCC Chapter 9.32.030) and 725 (RCC Chapter 1.16) authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.
