BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 348 (RCC Title 17), 520 (RCC Title 10), 541(RCC Chapter 8.120), 457 (RCC Title 15) and 725 (RCC Chapter 1.16) authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

Multiple Notices of Violation and Administrative Citations were issued. With regard to Case Nos. CV08-10823 and CV08-04649, the Board of Supervisors issued an Order to Abate on Jan. 11, 2011. Subsequently, the property owners voluntarily complied with regard to the violations of accumulated rubbish, excessive animals, excess outside storage of materials, occupied recreational vehicles and construction without permits. With regard to Case No. CV08-08651, the inoperable, wrecked and dismantled vehicles were abated under the direction of the Riverside County Code Enforcement Department pursuant to seizure warrant number MISC 2010-68.






