That certain Agreement between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Chander P. Malhotra, M.D., Inc. dated February 19, 2002, amended effective February 19, 2004, July 1, 2006, February 19, 2007, July 1, 2008, July 1, 2009, July 1, 2010 is hereby further amended effective July 1, 2011, pursuant to the following:

1. Delete the first (1st) sentence from Section 4.1 and replace with the following:

"This Agreement will be effective July 1, 2011 through June 30, 2012, and renew on an annual basis, unless terminated as otherwise provided herein."

All other terms and conditions of this Agreement are to remain in full force and effect.
