RESOLUTION BY THE BOARD OF SUPERVISORS

DISSOLVING THE GOOD HOPE

MUNICIPAL ADVISORY COUNCIL

WHEREAS, the Good Hope Municipal Advisory Council (MAC) was created on May 20, 1997 for the purpose of advising the Board of Supervisors on matters including, but not limited to, public health, safety, welfare, public works, planning; and

WHEREAS, in previous years the MAC has provided input to the Board of Supervisors on numerous matters regarding the Good Hope community; and

WHEREAS, on July 31, 2007 the Board of Supervisors adopted Resolution No. 2007-395 approving the Perris Valley Municipal Advisory Council which includes the communities of Good Hope, Good Meadows, Warm Springs and the Perris Valley region unincorporated area; and

WHEREAS, the creation of the Perris Valley Municipal Advisory Council to handle the affairs of this larger region of the Perris Valley and serve as the municipal body to accede the functions of the MAC; and

WHEREAS, Resolution 2005-148 Adopting Uniform Procedures for Advisory committees, Boards and Commissions, provides for the dissolution of any advisory committee no longer required for its original purpose:

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisor of the County of Riverside, assembled in regular session on Tuesday, September 13, 2011, that the Good Hope Municipal Advisory Council is dissolved, effective this date.
