BACKGROUND: (Continued)

The project located on a 12.05-acre site in the city of Menifee. The project consisted of the following improvements: 15,000 square foot community center, 10,000 square foot childcare center, two ball fields with lighting, picnic area, tot lot, 147 parking spaces and enhanced hardscape and landscaping. A tubular steel fence with pilasters surrounds the boundaries of the project on the north, west, and south side of the property. A walking trail was built on the south, west, and north side of the project. On-site lighting and off-site lighting has been installed as part of the project. Briggs Road has been built to ultimate width on the west side with a meandering sidewalk and water-wise landscaping.

Construction of the project has been completed and formal acceptance of the improvements is recommended.
