BACKGROUND continued:

Ordinance 860.8 includes rates the Auditor-Controller will charge for 20 of the services provided to county departments, taxing agencies outside the county (example cities and redevelopment agencies), special districts (example water districts); and, employees and the general public (for garnishments and similar services) as follows:

<u>Affected Agencies</u>	<u>Number of Rates</u>
Taxing Agencies (excluding county)	6
Employees and the general public	8
Special Districts	4
County Departments	2

The rate that will be charged to all county departments is for payroll warrants and direct deposits. The internal audit rate, which will be charged to the Tax Collector, is for the required quarterly verification of the assets held in the treasury.

The property tax general services fee is intended to recover costs associated with researching and providing significant amounts of information requested by consulting agencies. The rate will not be charged to taxing agencies or for requests that fall under the California Public Records Act.

Changes reflected in this Form 11 only affect the seven property tax services fees. The remaining departmental fees will be reviewed and updated accordingly at a later date. The changes to the property tax services fees are a result of an in-depth analysis of the level of effort required to complete these tasks.



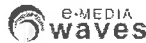


