SUBJECT: Notice of Intent to change the name of Fields Road and Johnson Lane to Malki Road, in the Cabazon area, Fifth Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2011-256, Notice of Intent to change the name of Fields Road and Johnson Lane to Malki Road.

BACKGROUND: This street name change has been requested by the Morongo Band of Mission Indians. The Morongo Tribe Council seeks to establish a more culturally sensitive identity for the principal southern point of entry into the Morongo Indian Reservation, as well as, desires to recognize the Reservation's historic past. A resolution was adopted by the Tribe at their Tribal Council meeting of September 6, 2011 which is attached. It is the Tribe's goal to increase access to the Malki Museum which will be accessed from the newly named Malki Road.

This action starts the name change process and sets a public hearing to consider this request. The Banning City Council will be considering this request at their September 27, 2011 meeting.
