**BACKGROUND:**

The EDA State of the County event will highlight accomplishments from each Supervisorial District and give attendees and insight into what lies ahead for the county in the future.

The College Voc-Tec Night 2011 is taking place on Oct. 12<sup>th</sup> at the Riverside County National Date Festival Fairgrounds. The event is hosted by the following high schools; Desert Mirage, Coachella Valley, Amistad, La Familia and West Shores.
