BACKGROUND: On August 28, 2007 the Board of Supervisors established the Desert Hot Springs Municipal Advisory Council under Resolution No.2007-420 as an advisory body to the Fifth District. The adoption of the Municipal Advisory Council was intended to provide input to the Fifth District on issues and concerns of the Desert Hot Springs community, and the unincorporated area around the Desert Hot Springs region. On September 13, 2011, the Board of Supervisors adopted Ordinance 911 establishing new supervisorial district boundaries which moves Desert Hot Springs and the surrounding unincorporated area into the Fourth District. Resolution 2005-148, Adopting Uniform Procedures for Advisory committees, Boards and Commissions, provides for the dissolution of any advisory committee no longer required for its original purpose.
