

Background (continued):

As part of the recommendation, it was determined that use of a beverage which is lightly flavored, contains electrolytes and contains sugar/carbohydrates to maintain mental performance (which can be hampered by decreased blood sugar) would be the best combination for firefighters. Firefighters also have an additional component to deal with and that is the "adrenaline rush" of the dangerous nature of the work. This adrenaline rush causes a fight or flight reaction in the body, thus changing the physiological response of the body to that of football player or even an endurance athlete, such as a marathon runner. Firefighters are often required to utilize maximum output for short times but also must be able to pace high level activity for prolonged periods. The other major issue is that in both other types of exertion the "danger" of life threatening activities does not exist.

The study also noted that sports drinks with too much sugar content caused two separate physiologically complex issues. The first issue was that high sugar content inhibited the absorption of water into the digestive track. The second issue was that higher sugar content also caused potential for nausea. This occurs during a "fight or flight" reaction when the body determines that it needs the blood flow to the muscles and the brain, not to digest food, thus causing the stomach to purge its contents (making a person nauseated or vomit). Both nausea and vomiting will reduce the productivity of the firefighters. It was determined that a reduced sugar content will prevent this process.

Fire Department personnel have been dumping a portion of the full Gatorade Sport Drink out and replacing it with water to dilute the product down to approximately half strength, or the sugar content of G2. However this caused two separate issues. First personnel were wasting half of the Gatorade, causing an increased cost. Secondly, but more importantly they were also reducing the amount of electrolytes by 50%. Firefighters also stated that they preferred the taste of the "G2" over any other sports drinks because it was not as sweet. We have been unable to locate other sports drinks that offer reduced sugar content. Other versions "lite" or "zero" have no sugar and no carbohydrates, which do not meet the needs for supplying the needed sugars and carbohydrates that will "fuel" our firefighting "industrial athletes." Several of the full strength versions contain more sugar than the original Gatorade.
