## MINUTES OF THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE, STATE OF CALIFORNIA



On motion of Supervisor Tavaglione, seconded by Supervisor Buster, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, October 18, 2011, is adjourned in memory of Howard H. "Tim" Hays Jr., a 94-year-old former editor, owner, and publisher of The Press Enterprise of Riverside, California, for a half-century. Tim was "one of the great, principled editors of his generation and one of his generations's foremost advocates of the First Amendment."

After graduating from Stanford University in 1939 and earning a law degree from Harvard Law School in 1942, Tim spent several years as a special agent for the FBI during World War II. In 1946, he joined the Press Enterprise as an assistant editor under his father Howard H. Hays Sr., and became editor three years later. Under his direction, the publishing of zoned editions for individual communities was established and daily circulation grew from 18,000 in 1946 to 167,000 in 1997.

Tim forged a vision for future government while leading the newspaper's crusade for openness in courtrooms, resulting in two separate Supereme Court rulings which are commonly referred to in First Amendment cases as Press Enterprise I and Press Enterprise II. In 1984, the Supreme Court ruled unanimously that the public has a presumptive right to observe jury selection, and in 1986, the high court ruled 7-2 that the public has a right to view pretrial hearings.

Although Tim was "quietly forceful and unyielding" in his causes, he will always be remembered for his "humble and unpretentious" soul. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.
