

SUBJECT: 2012 Board of Supervisors Meeting Schedule

BACKGROUND: The Board of Supervisors will meet to conduct the business of the County of Riverside County on most Tuesdays of each week throughout the year of 2012. It has been the practice of the Board to be dark on the Tuesdays following legal holidays that occur on a Monday (these holiday and dark dates are denoted on the attached calendar). However, the Chairman of the Board reserves the ability to schedule a Tuesday meeting on any of the scheduled dark dates due to the economic and budgetary constraints facing the County of Riverside and the possibility that the Board will need to take legislative action. 
