**SUBJECT:** LPS (5150) Designation of Facility for Involuntary Detention of Mentally Disordered Persons for Evaluation and Treatment.

**RECOMMENDED MOTION:** Move that the Board of Supervisors:

1. Designate Aurora Las Encinas Hospital, a 118 bed inpatient psychiatric facility located at 2900 East Del Mar Boulevard, Pasadena, California 91107, as a facility for 72-hour treatment and evaluation pursuant to California Welfare and Institutions Code, Section 5150 et. Seq.

**BACKGROUND:** Aurora Las Encinas Hospital is a General Acute Care Hospital with a 118 bed psychiatric unit. Aurora Las Encinas is located in L.A. County, and is currently designated by Los Angeles County as a 5150 patient receiving facility for Los Angeles County.

**SUBJECT:** LPS (5150) Designation of Facility for Involuntary Detention of Mentally Disordered Persons for Evaluation and Treatment.

**BACKGROUND (continued):**

Due to an increased need for acute hospital services for County of Riverside constituents with severe mental illness, the Riverside County Department of Mental Health is in need of additional acute hospitalization beds for their patients that are currently receiving treatment at the Riverside County Emergency Treatment Services (ETS) facility, and subsequently requires a 5150 designated facility for continued medical care and mental health treatment.

Therefore, pursuant to the California Welfare and Institutions Code, Section 5150, the RCDMH is requesting that the Riverside County Board of Supervisors designate the Aurora Las Encinas Hospital's 118 bed, inpatient psychiatric facility, located at 2900 East Del Mar Boulevard, Pasadena, California 91107, as a facility for involuntary detention of mentally disordered persons for evaluation and treatment under the general acute care license of Aurora Las Encinas Hospital.
