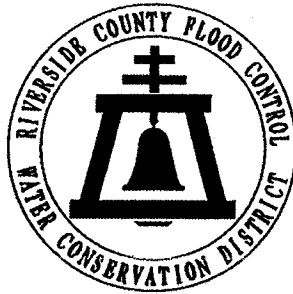

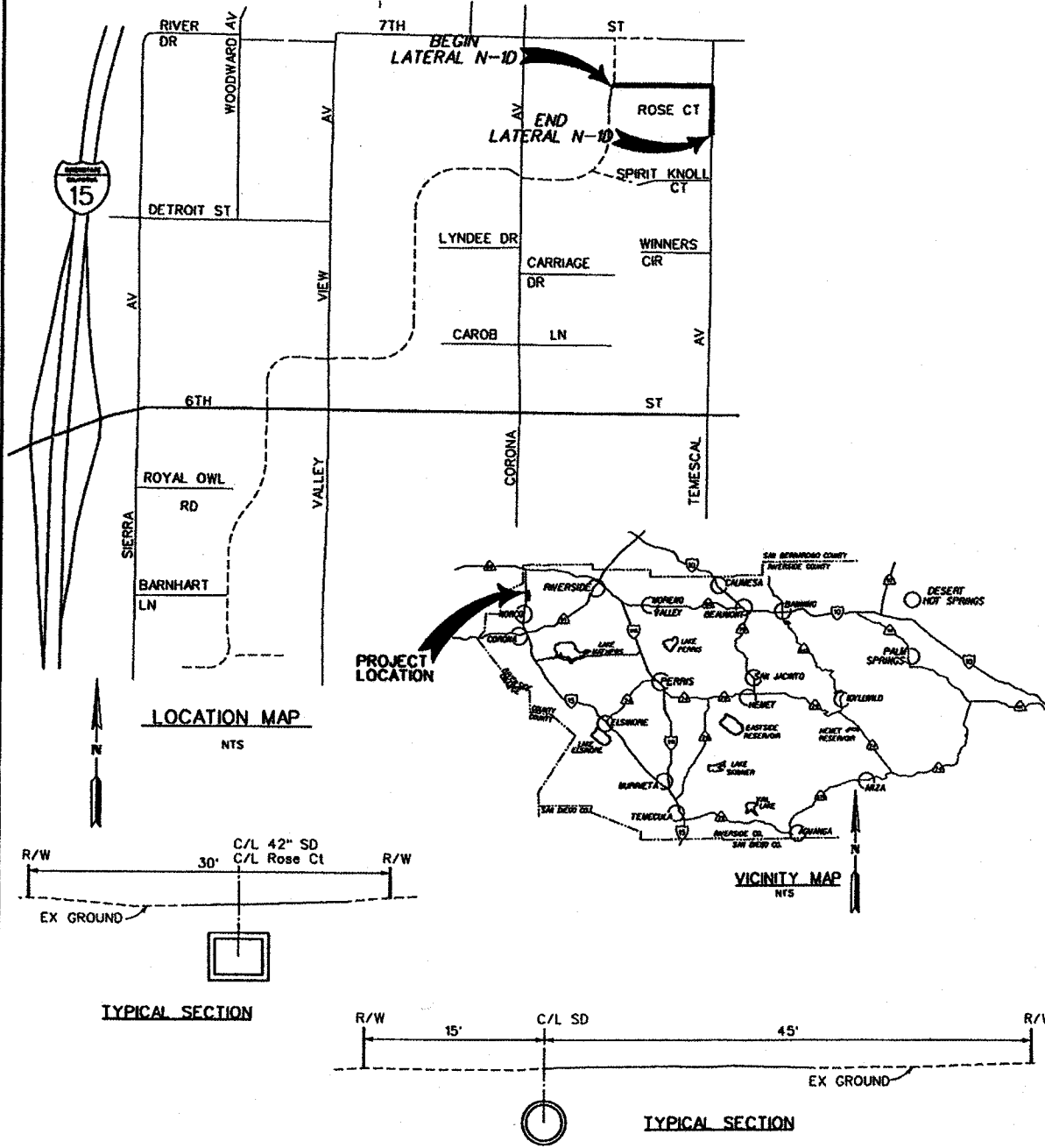
**Engineer's Statement**

The proposed project is located within the City of Norco, Riverside County, California. The project is an underground system to alleviate the flooding along Rose Court, Temescal Avenue and Spirit Knoll Court. The proposed project consists of two laterals: Spirit Knoll Court lateral is approximately 1160 linear feet of reinforced concrete pipe (RCP) and N-1D lateral is approximately 960 linear feet of reinforced concrete box (RCB). The laterals will connect to the existing North Norco Channel. The cost of the proposed project is approximately \$1,400,000.

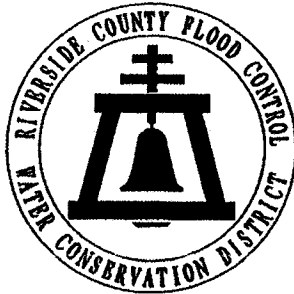
