Bob was a loving husband to his wife Carol and a devoted father, step-father, grandfather, teacher, and friend who will always be remembered as a "basketball enthusiast" who enjoyed watching his son play and for his childhood fascination of pigeons which led to his hobby of fancy pigeon breeding and involvement with the North American Capuchine Club. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.

On motion of Supervisor Benoit, seconded by Supervisor Buster, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, October 25, 2011, be adjourned in memory of Lucia Ruth Moran, a 60-year-old prominent resident of La Quinta who will always be remembered for her "kindness and selfless commitment to her family, friends, community, and her many causes."

Born on April 3, 1951, in Lynwood, California, Lucia moved to Cathedral City in the 1970's and then to Palm Desert before settling in La Quinta, where she met and married Mark Moran and became an instrumental force in the community she loved. Shortly after the city's incorporation and joining the Planning Commission, she authored the "Dark Sky Ordinance," assisted with the "Hillside Development Ordinance" in Coachella Valley, and led the "Trash Busters" initiative coordinating the removal of trash in La quinta for over 10 years. As an active member of various organizations, she was on the Board of Directors for the Boys and Girls Club of Coachella Valley and was part of the building committee that planned the La Quinta Clubhouse, Coachella Clubhouse, and Mecca Clubhouse. She was founder and Race Director for the Coachella Valley All American Soap Box Derby, as well as chairperson of the Boy Scouts of America Distinguished Luncheon, which resulted in raising thousands of dollars for local Scout Troops, and was one of the founding members of the La Quinta Senior Center Back Pack Luncheon Reading Program. She also served on the Health and Juvenile Intervention Committee for the Regional Access Project Foundation and the Riverside County Transportation Commission's Citizen Advisory Committee.

Because of her endless dedication and commitment, Lucia was chosen as "Citizen of the Year" in 1997 by the La Quinta Chamber of Commerce, in addition to receiving the "Silver Beaver" award from Boy Scouts of America and "A Woman of Distinction" award by Soroptimist International of La Quinta in 2000. In 2006, she was inducted as a "Pillar of the Community" for the City of La Quinta.

Lucia was a devoted wife, step-mother, aunt, and friend whose memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be dearly missed.
