SUBJECT: Adoption of Resolution No. 2011-267 Approving the application for grant funds for Waste Tire Enforcement

RECOMMENDED MOTION: That the Board of Supervisors adopt County Resolution No. 2011-267 authorizing the Code Enforcement Department to submit applications to the State of California Department of Resources, Recycling and Recovery or CalRecycle for all available grants under the Waste Tire Enforcement program for fiscal years 2012/2013 through 2017/2018.

BACKGROUND: The County of Riverside has been receiving this grant money for several years. The Code Enforcement Department started the program with approval of the Board of Supervisors. The Department of Resources, Recycling and Recovery (CalRecycle) requires the recipients to update their resolutions every five years.

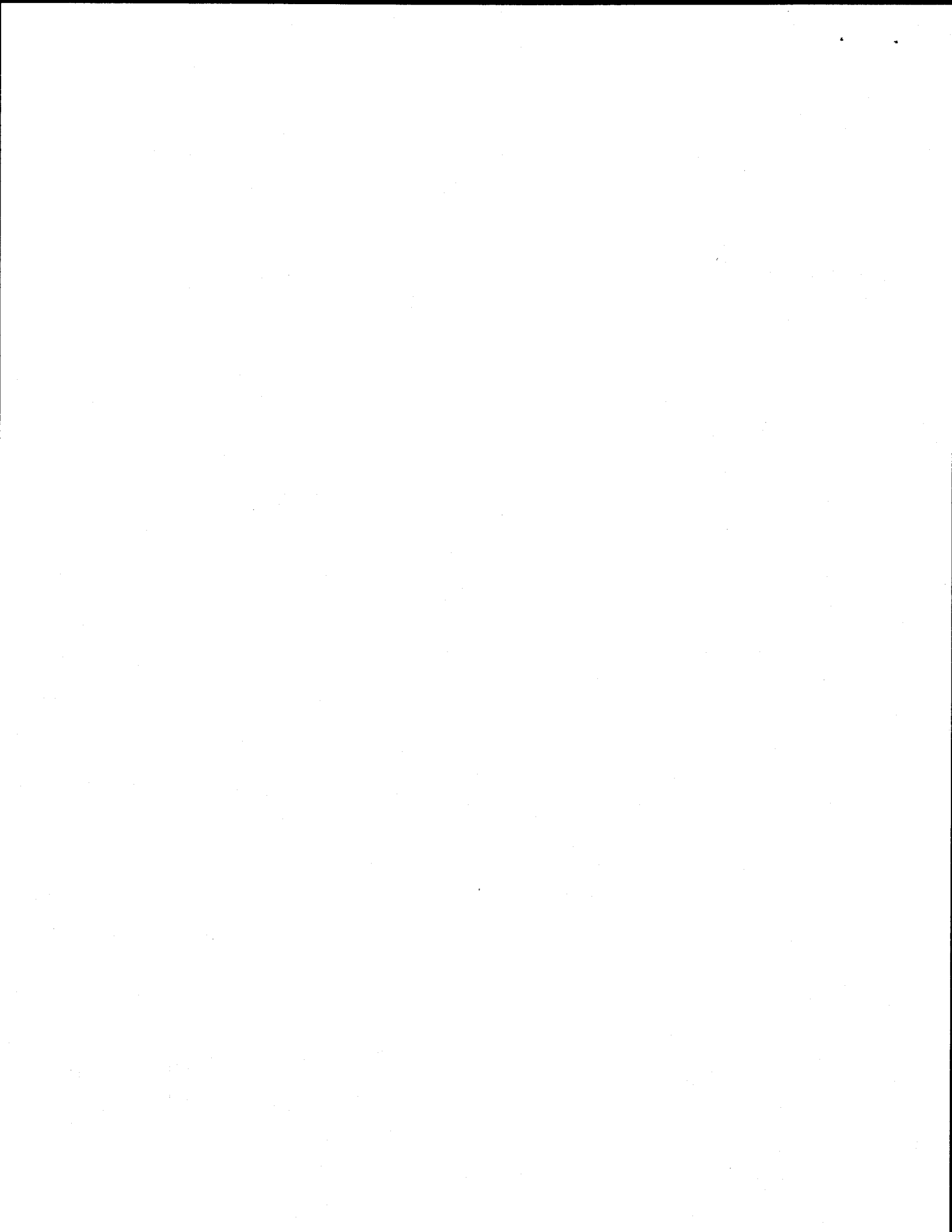

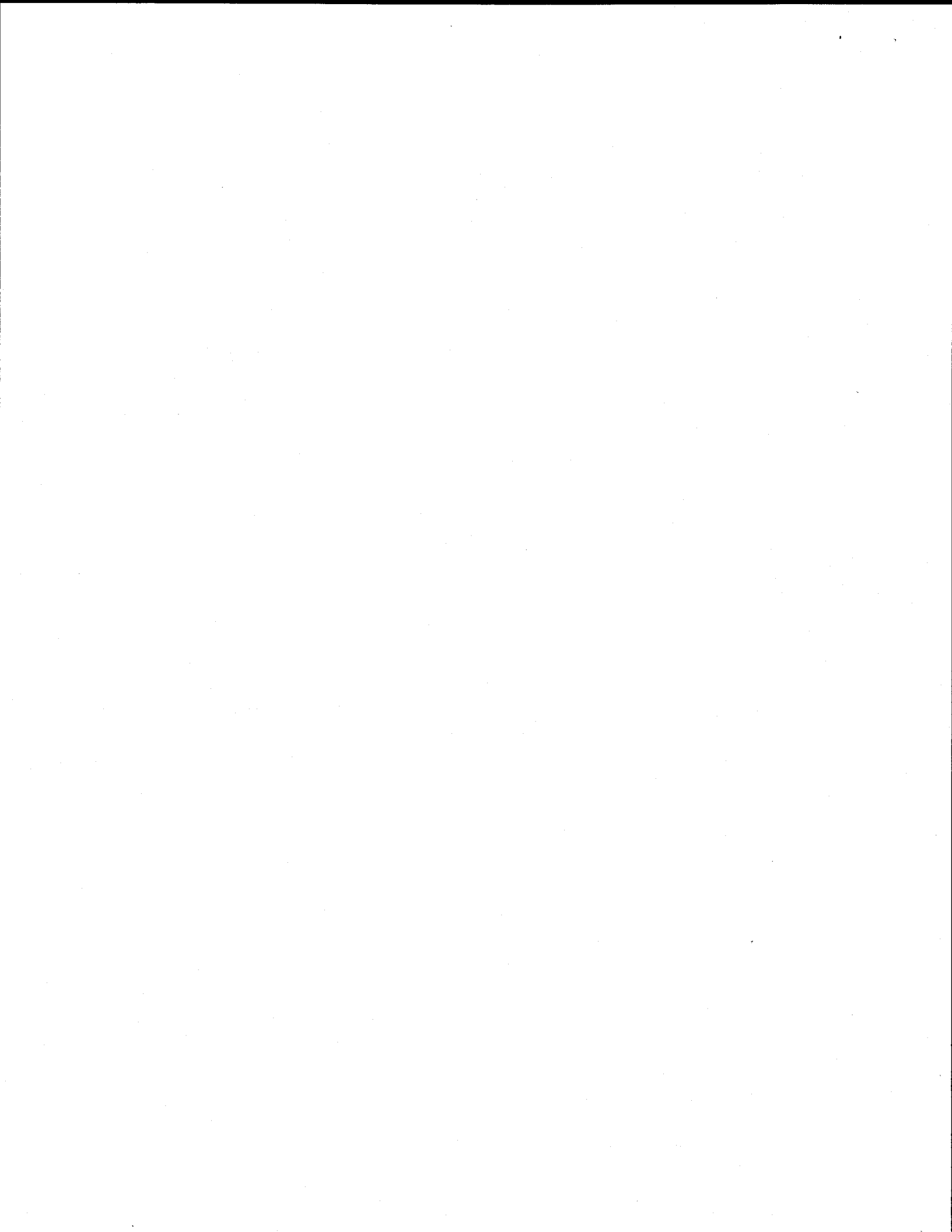

Code Enforcement uses this money to inspect waste tire facilities, tire dealers, auto dismantlers, tire haulers, and other points of waste of waste tire generation to ensure compliance with all applicable laws and regulations, including the manifest system and investigate complaints, referrals and illegal tire disposal activities.

The grant request is for \$600,000 per year. CalRecycle staff has indicated that the county may be eligible for similar level funding over the next five years, subject to the availability of funds and population served. All costs to be funded must be directly and clearly related to implementation and operation of the program funded by this grant.

The Boards action today will allow for Code Enforcement to submit an updated resolution and continue to apply annually for the Waste Tire Enforcement grant through fiscal year 2017/2018. Code Enforcement will return with any grant awards to the Board on an annual basis for approval to receive funding per Board Policy A-30.

Board Policy A-30 on personnel does not apply since the staff assigned to this program have other duties not related to the tire grant.



RESOLUTION NO. 2011-267

A RESOLUTION OF THE COUNTY OF RIVERSIDE AUTHORIZING SUBMITTAL OF A WASTE TIRE ENFORCEMENT GRANT APPLICATION

WHEREAS, funds are allocated and available from the California Department of Resources Recycling and Recovery (CalRecycle) for grants to solid waste Local Enforcement Agencies and cities and counties with regulatory authority within the city and county government to perform enforcement/compliance and surveillance activities at waste tire facilities; and

WHEREAS, the California Department of Resources Recycling and Recovery has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by cities and counties under the program; and

WHEREAS, procedures established by CalRecycle require a jurisdiction applicant to certify by resolution the approval of the jurisdiction's governing authority for submittal of a grant application before submission of said application to the CalRecycle; and

WHEREAS, the applicant shall consider entering into an agreement with CalRecycle for continuation of the waste tire enforcement program as authorized by the grant agreement; and

WHEREAS, should the County of Riverside be awarded funds under the CalRecycle Waste Tire Enforcement grant, the Director of the Riverside County Code Enforcement Department will submit a final agreement to the Board of Supervisors for approval;

NOW, THEREFORE, BE IT RESOLVED that the Riverside County Board of Supervisors authorizes the submittal of an application to the Department of Resources Recycling and Recovery (CalRecycle) for all available Waste Tire Enforcement Grants for fiscal years (FY) 2012/13 through 2017/18.
