**SUBJECT:** University of California Riverside County Partnership Agreement Authorization

**RECOMMENDED MOTION:** That the Board of Supervisors directs:

1. The Riverside County Economic Development Agency and/or the Commissioner of Foreign Trade (EDA) to enter into and complete negotiations with the University of California Riverside with the goal of establishing a Partnership Agreement with the Office of the Chancellor in collaboration with the Director of Athletics and designees from the University as determined by the Chancellor. The County's negotiation team is to identify up to \$60,000 to be used over a 36 month period. The funding will support promotion of UCR athletic exposure of the region and UCR through television, radio, newsprint, social media, outdoor advertising and other electronic media. Out-of-town visitors to local sporting events will stay in local hotels, eat at local restaurants and purchase products and memorabilia during their visits.
2. Upon completion of this 36-month promotional campaign, the Assistant County Executive Officer of the Economic Development Agency is to report back the status of the partnership effort and its effectiveness as an economic stimulus for the County of Riverside and University of California Riverside.
