SUBJECT: Amendment A3 to the Agreement to Reimburse the County for the Provision of Simulator Training at the Sheriff's Ben Clark Public Safety Training Center

RECOMMENDED MOTION: Move that the Board of Supervisors approve Amendment A3 to the Agreement with the Commission on Peace Officer Standards and Training (POST) to reimburse the County for the provision of simulator training at the Ben Clark Public Safety Training Center (BCTC) during FY 2010-11, and authorize the Chair to sign all copies of the Agreement.

BACKGROUND: On 6/8/10 (3.62) the County Board approved an Agreement with POST for the Commission to reimburse the County for the Sheriff's provision of driving simulator and a force options simulator training to full-time, on-duty law enforcement officers.

Amendment A3 to the FY 2010-11 POST Reimbursement Agreement for Simulator Training BR 12-043 Page 2

POST Amendment A1, approved and executed by the Board on 1/25/11 (3.25), reduced the amount reimbursable to \$79 per student and increased the number of students attending each course to 1,172. Per these changes, the total amount encumbered was increased to \$185,176.

POST Amendment A2, approved and executed by the Board on 1/25/11 (3.25), decreased the amount of students attending each course from 1,172 to 727, and the amount reimbursable to the County decreased from \$185,176 to \$114,866.

POST Amendment A3 extends the Agreement term through to September 30, 2011. Further, it increases the estimated amount of students attending each course from 727 to 1,143, and the amount reimbursable to the County is increased from \$114,866 to 180,594. County Counsel has approved Amendment A3 as to form.
