BACKGROUND: On June 28, 2011, by Minute Order 13.1 your Honorable Board approved a contract between the Regional Park and Open-Space District and the Spectra Company for the Jensen/Alvarado Historic Ranch and Museum Ceiling Replacement Project.

The original contract price was \$46,800. One change order was issued for \$4,650 (9.9% of the contract amount), bringing the final contract price to \$51,450. This change order was for the inclusion of another room in the overall project.

The work has been satisfactorily completed and is in compliance with the contract documents.
