Born on April 14, 1937, in Milwaukee, Wisconsin and later relocating to Edgemont, Washington with his family, Jim attended Fife High School, excelling in sports as a quarterback and punter for the football team and was a competitive swimmer and diver as well. After graduating from high school, he enlisted with the United States Marine Corps and was stationed in Barstow, California, where he met his soulmate and wife Arlene of 54 years.

Upon his honorable discharge from the USMC, Jim attended San Bernardino Valley College and graduated with a Bachelor of Science Degree from Loma Linda School of Physical Therapy as a Registered Physical Therapist and then earned a certification in Electromyography. Prior to starting his private Physical Therapist practice in San Bernardino in 1978, he was the Chief Physical Therapist and Director of Rehabilitation Services at the San Bernardino Community Hospital and the Ballard Rehabilitation Center. In 1995, he partnered with Jim Ferguson until his retirement in 2009.

As a true humanitarian who touched many lives, Jim dedicated his life to serving his community and was involved with various charitable and civic causes. In memory of their daughter, Carol Kathleen, Jim and Arlene founded "Carol's Kitchen" to help feed and clothe the needy in the San Gorgonia Pass area.

Jim was a loving husband, father, grandfather, great-grandfather, and friend whose whose memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.
