

SUBJECT: City of Jurupa Valley Election Date

RECOMMENDED MOTION: That the Board of Supervisors approve the City of Jurupa Valley's request to hold elections in November of even numbered years.

BACKGROUND: California Elections Code §§ 1301 and 10403.5 allow cities to consolidate their election with Elections held in November of even numbered years with the Board of Supervisors approval. The code further stipulates that the Board shall approve such request unless the ballot style, voting equipment, or computer capability is such that additional elections or materials cannot be handled. The Registrar of Voters can accommodate this request.

State law also requires that within 30 days after approval of the ordinance, a notice is to be mailed to all registered voters of the City informing them of the election date and the terms of

ORDINANCE NO. 2011-11

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF JURUPA VALLEY, CALIFORNIA, ADDING SECTION 2.05.005 TO THE JURUPA VALLEY MUNICIPAL CODE PROVIDING FOR GENERAL MUNICIPAL ELECTIONS TO BE HELD EVERY TWO YEARS ON THE DATE OF THE STATEWIDE GENERAL ELECTION WHICH IS NOVEMBER OF EVEN NUMBERED YEARS

THE CITY COUNCIL OF THE CITY OF JURUPA VALLEY DOES ORDAIN AS FOLLOWS:

Section 1. Section 2.05.005 is hereby added to the Jurupa Valley Municipal Code to read as follows:

"2.05.005. Municipal Election Date. The electors of the City shall elect council members at the general municipal election held every two (2) years on the date of the statewide general election on the second Tuesday following the first Monday in November of even-numbered years. The general municipal election shall be conducted in accordance with all applicable procedural requirements of the Elections Code. As provided by the Elections Code, the City Council may adopt a resolution consolidating the general municipal election with the County election."

- Section 2. The City Clerk is hereby directed to submit this ordinance to the Riverside County Board of Supervisors for approval by such body to the extent required by and in accordance with Elections Code sections 1301(b) and 10403. The ordinance shall not become effective unless and until it is approved by resolution of the Board of Supervisors.
- Section 3. The City's first general municipal election shall be consolidated with the statewide election to be held in November of 2012, at which time the seats of the two members receiving the lowest number of votes in the incorporation election shall be up for election as provided in Government Code Section 57377. The seats of the remaining three Council Members shall be up for election at the second general municipal election, which shall be consolidated with the statewide election to be held in November of 2014 as provided in Government Code Section 57377.
- Section 4. In the event that this ordinance is approved by the Board of Supervisors, and to the extent required by Elections Code section 10403.5(e), the City Clerk shall cause a notice to be mailed to all of the City's registered voters within 30 days of the Board's action informing the voters of the City's first succeeding election date and that as a result of the consolidation of the City's general municipal election with the statewide general election that the terms of office of each of the current Members of the City Council will continue until their successors are elected and qualified.

Section 5. The provisions of this Ordinance are intended to and shall supersede any Riverside County Ordinance adopted by the City that cover the same material as this ordinance or may be in conflict with it.

Section 6. The City Clerk of the City of Jurupa Valley shall certify to the passage and adoption of this Ordinance and shall cause the same to be published or posted in the manner required by law.
