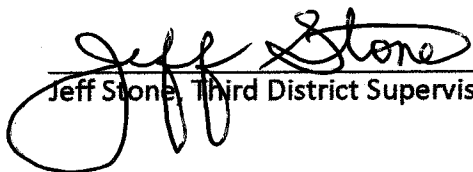
SUBJECT: Cellphone Return Ending Needless Demand Entirely in Riverside County  
(C-RENDER)

RECOMMENDED MOTION:

That the Board of Supervisors direct **Human Resources** with oversight in the **Executive Office** to contract with every consenting employee that has a county issued cellphone, to pay the employee a monthly stipend of **\$13.50** such that their personal cellphone can be utilized for county related business while employed by the County, and at the same time direct **Purchasing Department** to cancel all contracts with cellphone providers as those contracts expire and **surrender all county issued cellphones** where and when appropriate. Full implementation of this program will be **July 1, 2012**, which will save the county **\$1.5 million dollars** contributing to the closing of \$80 million dollar gap the county is now facing and saving many jobs.

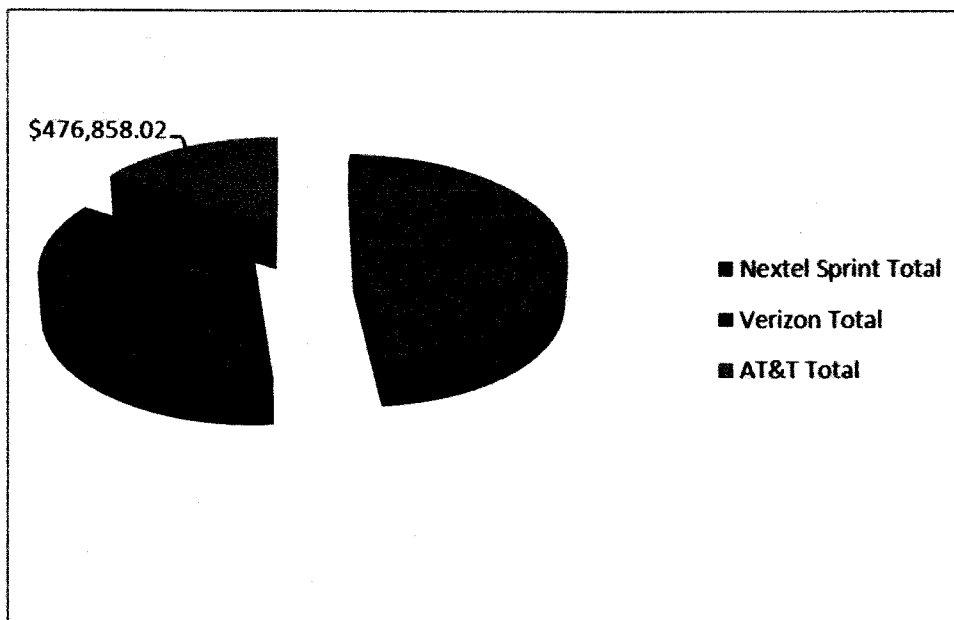
BACKGROUND:

As part of the Safeguard County of Riverside Against Preventable Expenses (S.C.R.A.P.E.) program, **unanimously** approved by the Board of Supervisors on February 3, 2009. Reduction in cellphone expenditures was highlighted as an area where the county could save significant financial resources when our economy was in the early stages of our fiscal collapse. Staff has reported that the county is still spending an excess of **\$3 million dollars a year** for cellphone expenses! It is estimated that the county has **9549 (Attachment 1)** issued cellphones at a costs to the taxpayers of **\$27.32 per month (Attachment 2 list by vendor, Attachment 3 expense by department)**! It can be assumed that most of our employees have a private cellphone in today's contemporary society. In an effort to save the county money and add value for the employees of the county that have their own private cellphones, the county proposes a **partnership** to those employees that have a county issued cellphone and have a private cell phone they utilize.
