Born on October 26, 1914, in Los Angeles, California, Willard graduated from Poly High School in Riverside and attended Riverside City College while supporting himself during the depression. In 1936, he married his soulmate Ardis Corwin and settled in her native Hemet, where they were both very involved throughout their 70 years of marriage.

As an instrumental force in the community, Willard served on the Hemet City Council as "Councilman Councilman" in the 1950's and was elected President of the Ramona Pageant Board in 1959, becoming general manager for 10 years. He also owned several businesses in town, including Valley Furniture, and was a member of Kiwanis, Exchange Club, and Lions Club.

Willard was a devoted husband to his wife, who preceded him in death, and a dedicated father, grandfather, great-grandfather, uncle, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be deeply missed.
