SUBJECT: : Approval of the budget adjustment for the implementation of California Assembly Bill (AB) 109 Criminal Justice Alignment funding, and amend Ordinance No. 440 pursuant to Resolution 440- 8877 submitted herewith.

BACKGROUND (CONTINUED):

The Riverside County Department of Mental Health (RCDMH) received an allocation from AB 109, to treat individuals who have substance abuse and/or mental health problems to support successful integration into the community and to prevent recidivism. Providing the appropriate level of care to this target population of nonviolent, non-serious, and non-high risk sex offenders, is essential to risk reduction. Services will be provided in specific geographic sites in the County, including in the jails, and a range of services will be available so the appropriate level of intervention will be provided to the AB 109 population with Mental Health and/or Substance Abuse problems. The RCDMH will provide assessment, care coordination, treatment, and housing as needed through existing and new programs.

The RCDMH will implement AB 109 by assigning experienced clinical staff to the Probation units who will be conducting the risk assessments of newly released individuals and the local inmate population no longer being sent to prison. The clinicians will conduct a clinical assessment of those individuals identified by the Probation department to be at risk or have a mental health and/or substance abuse history. The clinical staff will also review the treatment/assessment history information sent from the State prison for those clients with previously identified problems. The level of service to be provided in follow-up will be determined based upon the outcomes of these assessments, and information will be provided for inclusion in the clients overall case plan. Outpatient services, including medication support, groups and substance abuse treatment, will be provided to the AB 109 population, including services to those sentenced to the jails. In addition, substance abuse and mental health residential treatment services, plus other specialized programs, such as intensive case management; and crisis and psychiatric inpatient services will be provided as needed. Emergency housing will also be available for the severely mentally ill when required. Therefore, the RCDMH is requesting that the Riverside County Board of Supervisors approves the budget adjustment as outlined in Schedule A for the implementation of the AB 109 Criminal Justice Alignment funding.

PERFORMANCE PERIOD:

The period of performance for the AB 109 funding is from October 1, 2011 through June 30, 2012. It is anticipated that this will be continuously appropriated State funding.

FINANCIAL IMPACT:

The RCDMH will receive \$4,191,444 in AB 109 funds to provide various outpatient and intra-county services. All the RCDMH agreements for AB 109 funds will have negotiated rates based on the State approved Medi-Cal rate which will serve as a cost savings to the County. In addition, each agreement is subject to termination, as specified in the termination provisions of the agreement, due to unavailability of funding. No County funds are required.
