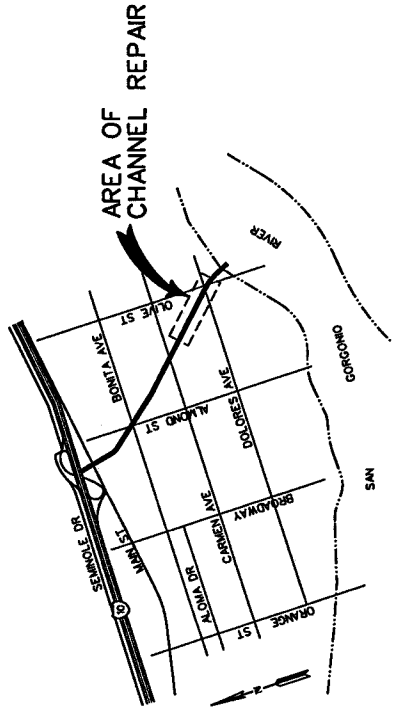

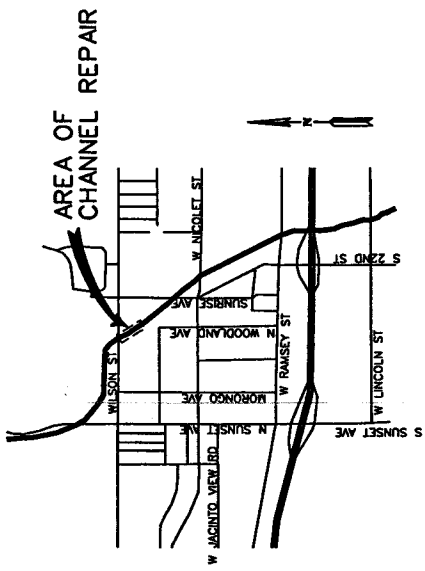
LOCATION MAP
