

BACKGROUND: On October 18, 2011, the County of Riverside entered into a contract with Southwest Construction for the Apron Rehabilitation at the French Valley Airport. The project consisted of applying the asphalt rejuvenating seal to tie-down and apron areas, and reapplying airfield makings. The project was completed on November 11, 2011, and the airport has been returned to its full operational capacity.
