

By Minute Motion, that the City Council, Authorize staff to donate the City's Fire Department Electric Vehicle to the Riverside County Fire Department.


Background

Fiscal Impact


There is no fiscal impact associated with this donation, as the City is not responsible for any maintenance or other costs associated with this vehicle.
