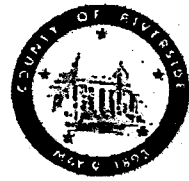

SUBJECT: In-Principle Approval for Leased Space and Office Expansion in Riverside, Murrieta, & San Jacinto for the Probation Department as a result of AB 109/117 & 118 Criminal Justice Alignment.


RECOMMENDED MOTION: That the Board of Supervisors authorize EDA/Facilities Management to:

1. Locate approximately 21,000 square feet of office space in Riverside and negotiate a full service, five (5) year lease for the Probation Department Adult Services Division.
2. Locate approximately 8,000 square feet of office space in Riverside and negotiate a full service, five (5) year lease for the Probation Department Risk Management Special Projects Division.
3. Locate approximately 11,000 square feet of office space in Murrieta and negotiate a full service, five (5) year lease for the Probation Department Southwest Adult/Juvenile Services Division.
4. Negotiate expansion of 5,000 square feet of office space for the San Jacinto location to include tenant improvements.

BACKGROUND: The Probation Department requests that the Board of Supervisors approve, In-Principle, the authority for EDA/Facilities Management, Real Estate Division to locate suitable office space in Riverside & Murrieta and to also negotiate an expansion leased of space in San Jacinto.



BACKGROUND: (Continued)

The Probation Department must relocate several divisions to meet the growing needs of the department. The current moves and expansions will provide office space for additional staff, training rooms, interview rooms, client drug testing rooms, and classrooms to fully implement the Realignment Legislation AB109/117 & 118. The offices will also need secured parking for county vehicles.

The Adult Services Division located on Franklin St. in Riverside, has outgrown their current location. The Adult Division currently occupies 13,000 square feet of office space but will need a total of 20,000 square feet of space to accommodate additional staff, a training room, and a classroom.

The newly created Risk Management Special Projects Division will need to relocate. The new division is currently located within Probation Administration but due to the expansion of the infrastructure, this unit will need to relocate. This division will need approximately 8,000 square feet of office space.

The Southwest Division which consists of the San Jacinto, Temecula and Murrieta Probation Offices will undergo a restructure. The current space in Temecula is 3,400 square feet and the configuration for this space does not meet the department's needs. The Temecula Office will be relocated near the Southwest Justice Center Courthouse along with the Investigations unit from the Southwest Murrieta Office. The consolidation will address the space issue as well as add client interview rooms, adequate facilities for client drug testing and a training room.

The Probation Office in San Jacinto will need an additional 5,000 square feet of office space which will include a training room, classroom, 5 interview rooms, and a client drug testing room.

There are sufficient funds in the Department's budget to pay for the annual lease costs. No additional General Funds are needed.
