The attached agreement will continue all current services through Mr. Walters. The agreement was prepared with a ten percent (10%) reduction to the compensation initially offered.

**FIRST AMENDMENT TO RENEW AGREEMENT  
BETWEEN COUNTY OF RIVERSIDE  
AND THOMAS WALTERS & ASSOCIATES INC.**

The Agreement between the County of Riverside (COUNTY) and Thomas Walters & Associates (CONSULTANT) approved by the Board of Supervisors on November 25, 2008 as Agenda Item 3.6 is hereby amended and renewed effective January 1, 2012 as follows:

1. Pursuant to Section 2. of the original Agreement, the Agreement is hereby extended and shall continue in effect through December 31, 2012.

2. The total compensation for January 1, 2012 through December 31, 2012, will be \$184,706 a reduction of ten percent (10%) from the original contract. The monthly bill shall not exceed \$15,392.

3. Article 3. Compensation, sub paragraph 3.2 is hereby deleted. Henceforth compensation will be determined on an annual basis.






