2. Approve the waiver of Board Policy B-28 for the use of unrestricted net assets to offset operating costs in the amount of \$1,300,000.

**BACKGROUND:** The OASIS FY 12/13 Financials and HRMS rates remain the same however the rates do not support current operational costs and will require the continued drawdown of net assets. Over the past 5 years, OASIS has augmented rates by spending down excess net assets.

**BACKGROUND: (Continued)**

The FY12/13 budget will maintain core system functions such as payroll, benefits administrations, accounting, vendor payments, purchasing, project costing, asset management and inventory control. Deferral of planned projects and future upgrades will be unavoidable. An in-depth analysis of the PeopleSoft operations will need to occur to determine how best to provide continued support to meet countywide business needs. This is especially critical as the remaining net assets will only support one more year of operations without a rate adjustment.

There is ongoing synergy between RCIT and OASIS operations and we have been able to reduce costs in areas of system operations, administration, support and facility costs. We will continue to look for additional cost savings measures as the organizations further integrate under new leadership. RCIT/OASIS is currently working with EDA to negotiate a combined space at the OASIS facility at Mission Grove so that we may combine three sites into one location. The relocation, including lease and moving costs will provide for a net reduction in on-going lease costs.
