THIRD AMENDMENT TO THE AGREEMENT BETWEEN COUTY OF RIVERSIDE AND LOMA LINDA UNIVERSITY UROLOGY MEDICAL GROUP, INC.

(CONTRACTOR) effective July 1, 2007, amended effective July 1, 2007 and June 1, 2011 and is hereby further amended effective **January 1, 2012**, pursuant to the following:

1. 12.0 ASSIGNMENT/DELEGATION

"Effective of the Effective Date noted above, Assignor (CONTRACTOR) hereby transfers, assigns, conveys, grants, and sets over to Assignee (CORPORATION) all its rights, title and interest in to the Agreement.

Assignee (CORPORATION) hereby accepts assignment granted herein, and assumes and agrees to perform and to keep all covenants and agreements of Assignor (CONTRACTOR) under the Agreement. Assignee (CORPORATION) agrees that the COUNTY shall be entitled to enforce against Assignee (CORPORATION) every term, covenant, and obligation under the Agreement in respect of the period for the term thereof from and after the Effective Date hereof with the same force and effect as though Assignee (CORPORATION) was named therein."

Delete Section 28 of this Agreement and replace with the following:

"28.0 <u>NOTICES</u>
