SECOND AMENDMENT TO AGREEMENT FOR LAW ENFORCEMENT SERVICES BETWEEN COUNTY OF RIVERSIDE AND CITY OF MENIFEE

IT IS MUTUALLY AGREED that the Agreement for Law Enforcement Services between the County of Riverside, a political subdivision of the State of California, on behalf of its Sheriff's Department, and the City of Menifee, a General Law City, approved by the Board of Supervisors on July 21, 2009, for services effective July 1, 2009 through June 30, 2012, as amended on September 28, 2010, is hereby amended in the following respects, and all other terms and conditions of the Agreement remain in full force and effect:
