RECOMMENDED MOTION: Adoption of Resolution No. 2012-041 for the Diminishment of Winchester Agricultural Preserve No. 2, Map No. 60, based upon the hereinafter listed findings and conclusions

### BACKGROUND:

Domenigoni and Barton Properties (Applicant), entered into a land conservation contract with the County of Riverside in 1970. The site is located northerly of Keller Road, southerly of Holland Road and both easterly and westerly of Highway 79. (See attached Exhibit A.)

The Applicant filed a notice of non-renewal on November 4, 1999, which was recorded on December 30, 1999. The land conservation contract for the property expired on January 1, 2010. Under both the County's Rules and Regulations Governing Agricultural Preserves and the State of California's Williamson Act Program, a landowner may apply to have property removed from the boundaries of an agricultural preserve once the contract has expired. Since the land conservation contract expired in 2010, the Applicant applied to have the subject site removed from the boundaries of the agricultural preserve. The attached Resolution 2012-041 (Exhibit B) formally accomplishes this action.

The diminishment of the site is consistent with the Williamson Act, the Rules and Regulations Governing Agricultural Preserves in Riverside County and with the County's General Plan.



# MAP NO. 60 **WINCHESTER AGRICULTURAL PRESERVE** NO. 2



RESOLUTION NO. 2012-041 DIMINISHMENT OF WINCHESTER AGRICULTURAL PRESERVE NO. 2

(Government Code Section 51231)

WHEREAS, Francis N. Domenigoni; Jean Domenigoni; Angelo O. Domenigoni; Julia M. Young; Frederick E. Domenigoni; and Elsa E. Barton, entered into a Land Conservation Contract with the County of Riverside pursuant to the California Land Conservation Act of 1965 (Government Code Section 51200 et seq.), which contract is dated January 1, 1970, and was recorded February 27, 1970, as Instrument No. 19058, in the Office of the County Recorder of Riverside County, California; and,

WHEREAS, said Land Conservation Contract is for a 1023.77 acre area located northerly of Keller Road, southerly of Holland Road, easterly of Eucalyptus Road, both easterly and westerly of Highway 79 in the unincorporated area of Winchester, Riverside County, California ("Property"); and,

WHEREAS, the Property is identified as Assessor's Parcel Numbers 466-150-007; 466-180-018; 466-170-023; 466-170-033; 466-240-002; 466-240-003; 466-240-004; 466-250-028; 466-260-001; 466-330-009; 466-330-010; 466-330-011; 466-330-012; 466-330-013; 472-120-006; 472-120-002; 472-120-003; 472-130-001; 472-130-002; and,

WHEREAS, in 1978 the Property was owned by Francis N. Domenigoni and Jean Domenigoni (Francis Domenigoni Family Trust), Frederick E. Domenigoni and Elsa E. Barton; and.

in 1990 a family partnership was formed called Domenigoni-Barton WHEREAS, Properties, a California General Partnership, whose partners were the Francis Domenigoni Family Trust, Frederick E. Domenigoni and Elsa E. Barton (Elsa E. Barton Trust U/D/T April 14, 1993); and,

WHEREAS, the Property collectively owned was placed in the ownership of Domenigoni-Barton Properties; and,

WHEREAS, on November 4, 1999, in preparation for the Property's future development, a Notice of Non-Renewal was filed by Domenigoni-Barton Properties and Francis Domenigoni Family Trust which notice was recorded on December 30, 1999, as Instrument No. 564989, in the Office of the County Recorder of Riverside County, California; and,

WHEREAS, the filing of the Notice of Nonrenewal resulted in the expiration of the Land Conservation Contract as it applies to the Property on January 1, 2010, pursuant to Government Code Section 51245 and 51246; and,

WHEREAS, Holland Heritage 120, WW 550 LLC, Fred 160 LLC and Craig 435 LLC are entities that were formed to assist in the Property's development and have an ownership interest in the Property; and,

WHEREAS, on January 19, 2011, Domenigoni-Barton Properties, as authorized representative for the current Property's owner (Domenigoni-Barton Properties, the Francis Domenigoni Family Trust, Holland Heritage 120, LLC, WW 550, LLC, and Fred 160, LLC) requested to have the Property removed from the boundaries of Winchester Agricultural Preserve No. 2.

**BE IT RESOLVED, FOUND, DETERMINED AND ORDERED** by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on <a href="March 13"><u>March 13, 2012</u></a> that:

- 1. The above recitals are true and correct and incorporated herein by this reference.
- 2. Under the County of Riverside's Rules and Regulations Governing Agricultural Preserves and the State of California's Williamson Act Program (i.e., Land Conservation Act), a landowner may apply to have property removed from the boundaries of an agricultural preserve, once the contract has expired.
- 3. Winchester Agricultural Preserve No. 2, Map No. 60, dated November 17, 1969, and on file in the Office of the Clerk of this Board, is amended by deleting therefrom the area shown on the map entitled "AGRICULTURAL PRESERVE MAP NO. 1022:
