2. Authorize the Chairman to execute the same, and authorize the Director of Transportation to execute administrative amendments within the funding amounts





**BACKGROUND:** The proposed project consists of replacing and widening the Van Buren Boulevard freeway and railroad overcrossing structures, reconfiguring and signaling of the on and off ramps and adding auxiliary lanes on Interstate 215. Landscaping and aesthetic features are also part of the project.

On December 7, 2010 the Board of Supervisors approved the Caltrans Construction Cooperative agreement, No. 08-1471 which outlined each agency's responsibility for the construction of the improvements to the I-215/Van Buren Boulevard Interchange. On September 13, 2011 the Board of Supervisors approved Amendment 1 to the agreement (08-1471 A/1) to: designate the County as the Legally Responsible Person and Approved Signatory Authority for construction; add Federal Demonstration (DEMO) Earmark Funds; add Federal Surface Transportation Program (STP) funds; reduce the construction capital funds based on the updated engineers estimate; and to replace the Trade Corridor Improvement Funds (TCIF) with Measure A funds, due to the inability of the State to sell bonds.

Amendment 2 to the Construction Cooperative Agreement is now required to replace the designated Measure A with TCIF funds due to bond approvals by the California Transportation Commission (CTC) making TCIF funds available for the project in the amount of \$10,000,000. The attached Agreement Amendment 2 includes the revised Funding Summary illustrating the funding adjustment.

Construction is anticipated to begin in the summer of 2012.

## AMENDMENT NO. 2 TO AGREEMENT 1471

THIS AMENDMENT NO. 2 (AMENDMENT), entered into and effective on \_\_\_\_\_, is between the State of California, acting through its Department of Transportation, referred to as CALTRANS, and

County of Riverside, a political subdivision of the State of California, referred to as COUNTY.

### RECITALS

1. CALTRANS and COUNTY, collectively referred to as PARTNERS, entered into Agreement No. 08-1471, (AGREEMENT) on December 15, 2010, defining the terms and conditions to reconstruct the Interstate 215 (I-215) and Van Buren Boulevard interchange in the County of Riverside, as well as, the realignment of I-215 due to right of way constraints and adjacent airport clearance requirements, referred to as PROJECT.
2. PARTNERS entered into Amendment No. 1 to AGREEMENT on September 22, 2011, to add language for the Legally Responsible Person and the Approved Signatory Authority as mandated by the Construction General Permit; add Federal Demonstration (DEMO) Earmark funds for Construction Capital; add Federal Surface Transportation Program (STP); reduce local's Construction Capital funds due to updated construction estimates; and to advance Local Funds in advance of the Trade Corridor Improvement Funds (TCIF).
3. Due to the bond approval by the California Transportation Commission and the availability of the TCIF, PARTNERS now seek to amend this coop and replace the \$10,000,000 in Local Funds with TCIF.

### IT IS THEREFORE MUTUALLY AGREED:

1. New Article is added in the AGREEMENT under DEFINITIONS to read as follows:  
  
"OBLIGATIONS – All responsibilities included in this Agreement."
2. Article 10 in the AGREEMENT is replaced in its entirety to read as follows:

6. New Article is added to the AGREEMENT under SCOPE (Scope: Construction) to read as follows:

“59.1 IMPLEMENTING AGENCY will use a CALTRANS-approved construction contract claims process, will administer all claims through said process, and will be available to provide advice and technical input in any claims process.”

7. A revised FUNDING SUMMARY, dated December 27, 2011 is attached and made part of the AGREEMENT. Any reference to the FUNDING SUMMARY in the AGREEMENT is deemed to refer to the revised FUNDING SUMMARY, dated December 27, 2011, attached herein.
8. All other terms and conditions of the AGREEMENT shall remain in full force and effect.
9. This AMENDMENT is deemed to be included and made part of the AGREEMENT.
