- 5) Authorize the Purchasing Agent to sign future contract amendments limited to the shifting of funds between budgetary line items as needed to facilitate the delivery of program services. Any amendments which would alter the original approved total grant award or change any given fiscal years revenues or modify the lifetime of the grant will be brought to the Board of Supervisors for approval.

BACKGROUND:

On November 2, 1999, Item 3.22, the Board authorized the Community Health Agency Department of Public Health Disease Control Branch (Department) to accept the first year of subvention funding from the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) to be issued to American Lung Association of California (ALAC) in a single source subcontract.

A second agreement between the Department and ALAC was approved by the Board on June 25, 2002, Item 3.17, to be funded by the same subvention funds, but allocated on a calendar year basis.

This Form 11 is to accept the Award in the amount of up to \$671,446 (\$614,221 for ALAC and \$57,225 for Riverside County Administrative cost) for the performance period of December 1, 2011 through November 30, 2012.

This budget overlaps County Fiscal Year 11/12 – 12/13. The department will use \$391,677 for Fiscal Year 11/12 (\$358,296 for ALAC and \$33,381 for Riverside County Administrative cost). The remaining funding of \$279,769 (\$255,925 for ALAC and \$23,844 for Riverside County Administrative cost) will be included in the Fiscal Year 12/13 budget.

That certain Agreement between the County of Riverside (COUNTY) and American Lung Association of California (CONTRACTOR), approved on June 25, 2002 Item 3.17, amended for the first time on February 25, 2003, item 3.5, amended for the second time on February 28, 2003, amended for the third time on July 1, 2003, Item 3.6, amended for the fourth time on October 7, 2003, Item 3.12, amended for the fifth time on August 10, 2004, item 3.20, amended for the sixth time on September 14, 2004, Item 3.11, amended for the seventh time on March 29, 2005, Item 3.7, amended for the eighth time on March 7, 2006, item 3.3, amended for the ninth time on March 13, 2007, Item 3.12, amended for the tenth time on March 18, 2008, Item 3.13, Item 3.13, amended for the eleventh time on February 24, 2009, Item 3.13, amended for the twelve time on May 25, 2010, Item 3.12, amended for the thirteenth time on May 3, 2011, Item 3.3, is hereby amended for the fourteenth time as follows, effective December 1, 2011:

- To amend all references to the period of performance from December 1, 2010 through November 30, 2011 to December 1, 2011 through November 30, 2012.
- Compensation to CONTRACTOR, per the State California Department of Public Health award letter # FEDS1112ISIT, for the above performance period, shall not exceed six hundred fourteen thousand, two hundred twenty-one dollars (\$614,221) including all expenses.

- All other terms and conditions of this Agreement are to remain unchanged.

**REVISED LETTER OF AWARD – FEDS1112ISIT, \$671,446
FUNDING PERIOD – December 1, 2011 through November 30, 2012**

This letter supersedes the Letter of Award dated December 30, 2011. The purpose of re-issuing this letter is to augment the amount of this award.

This letter is confirmation of local assistance funding to support the federally funded activities as described in the Centers for Disease Control and Prevention's (CDC) Cooperative Agreement with the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB).

AWARD

Riverside County Community Health Agency, Department of Public Health will receive up to \$671,446 from the CDPH TBCB to support the federally funded activities as described in the CDC Cooperative Agreement. The duration of these funds will be for a 12-month period, December 1, 2011 through November 30, 2012.

Allocation of these funds is contingent upon receipt of the funds from the CDC. These funds are being awarded with the understanding that your program staff will work with CDPH TBCB staff in carrying out your CDPH TBCB-funded TB control efforts.

The amount of this award includes a 10% administration charge.

MANAGING YOUR AWARD

Reimbursement of expenditures is contingent upon compliances with the requirements and procedures governing local assistance awards described in the 2011-2012 Policies and Procedures Manual (PPM), located at <http://www.cdph.ca.gov/programs/tb/Pages/LocalAssistanceAward.aspx>.

You will receive a new manual for July 1, 2012 – June 30, 2013 with the announcement of your local assistance Base Award in February. The manual for FY 2011-2012 should be used until June 30, 2012.

Exceptions to PPM requirements for this award are as follows:

- Invoices may be submitted monthly for this project, rather than quarterly as stated in the PPM.
- Prior approval of a written budget revision request is not required as stated in the PPM Part 2, Section 2, if aggregate expenditures in an approved budget line item do not exceed ten percent (10%).

ACCEPTANCE OF YOUR AWARD

To acknowledge your acceptance of this award and the conditions attached to it, please return an original of the enclosed "Acceptance of Award" with an authorized signature to the CDPH TBCB. No further documentation of this contract is necessary. The CDPH TBCB cannot process your invoices until we have received this document.

Additionally, the subcontractor indirect cost will be assessed at the rate of 20% of Personnel and Benefits for a total of \$41,971. These expenditures have been included in the amount of your award. 
