SUBJECT: Notice of Intention to vacate a portion of Maitri Road in the Glen Ivy Hot Springs area, First District / First District.

RECOMMENDED MOTION: Adopt Resolution No. 2012-102, Notice of Intention to vacate a portion of Maitri Road in the Glen Ivy Hot Springs area.

BACKGROUND: Due to repeated theft, vandalism and illegal dumping occurring at their mining operation, the applicant, Mayhew Land Company, LLC, has requested that a portion of Maitri Road, a County maintained road, be vacated. This will allow the applicant and other ownerships to control access to the property adjacent to the road. The applicant is also representing four additional property owners/corporations who have granted their permission for the vacation of Maitri Road, which are the only property owners/corporations properties accessed by Maitri Road, with said Maitri Road terminating within said property owners/corporations properties. No access will be eliminated to any parcel. Access easements have been agreed upon between the applicant and the City of Corona and Elsinore Valley Municipal Water District (EVMWD) for access to the water wells and associated facilities on the applicants properties. The Transportation Department, Fire Department, City of Corona, and EVMWD have reviewed the vacation request and have no objections. This vacation was presented to the Planning Commission on August 3, 2011. The Planning Commission recommended approval of the vacation.

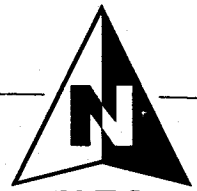

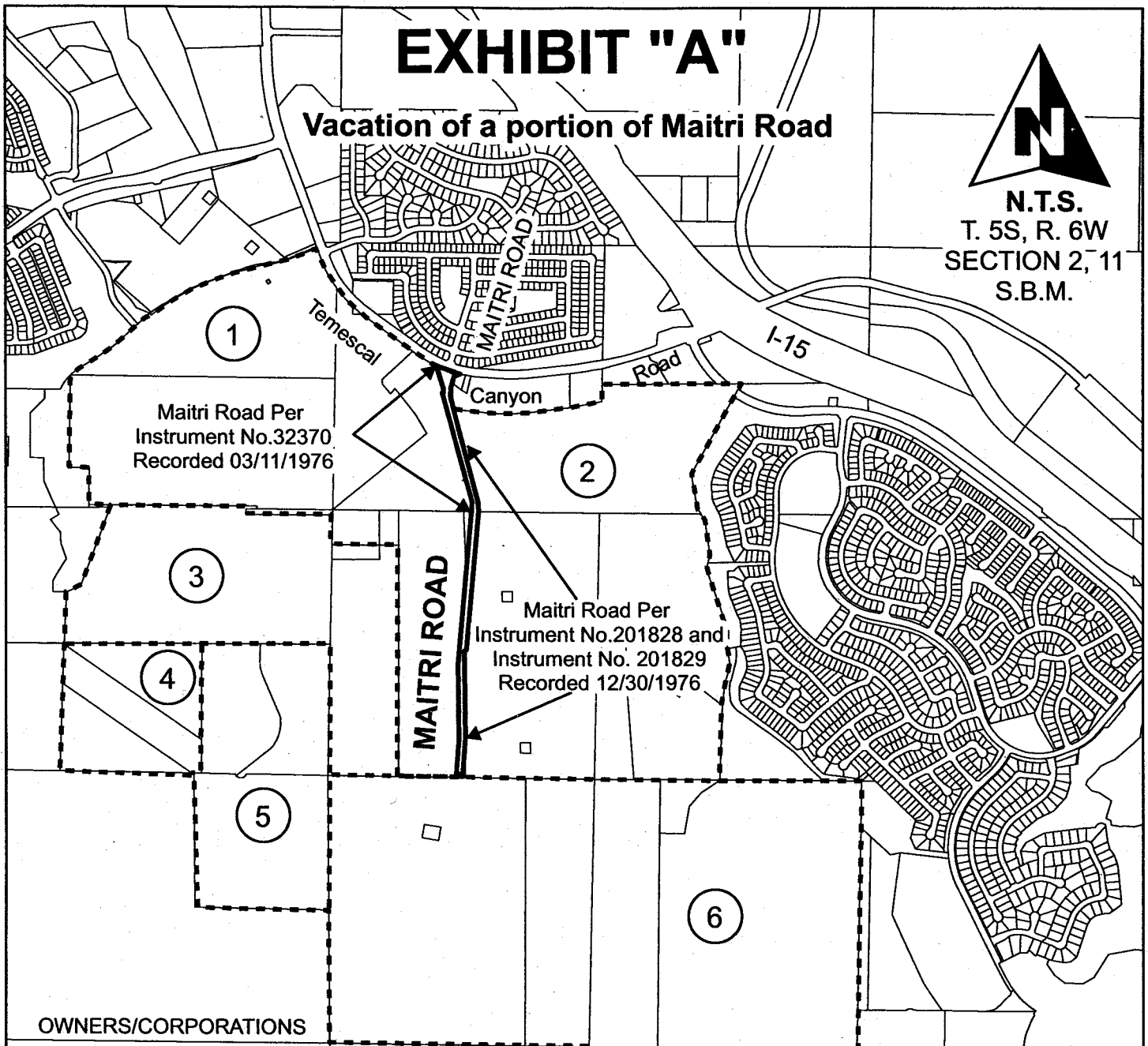

Vacation of a portion of Maitri Road

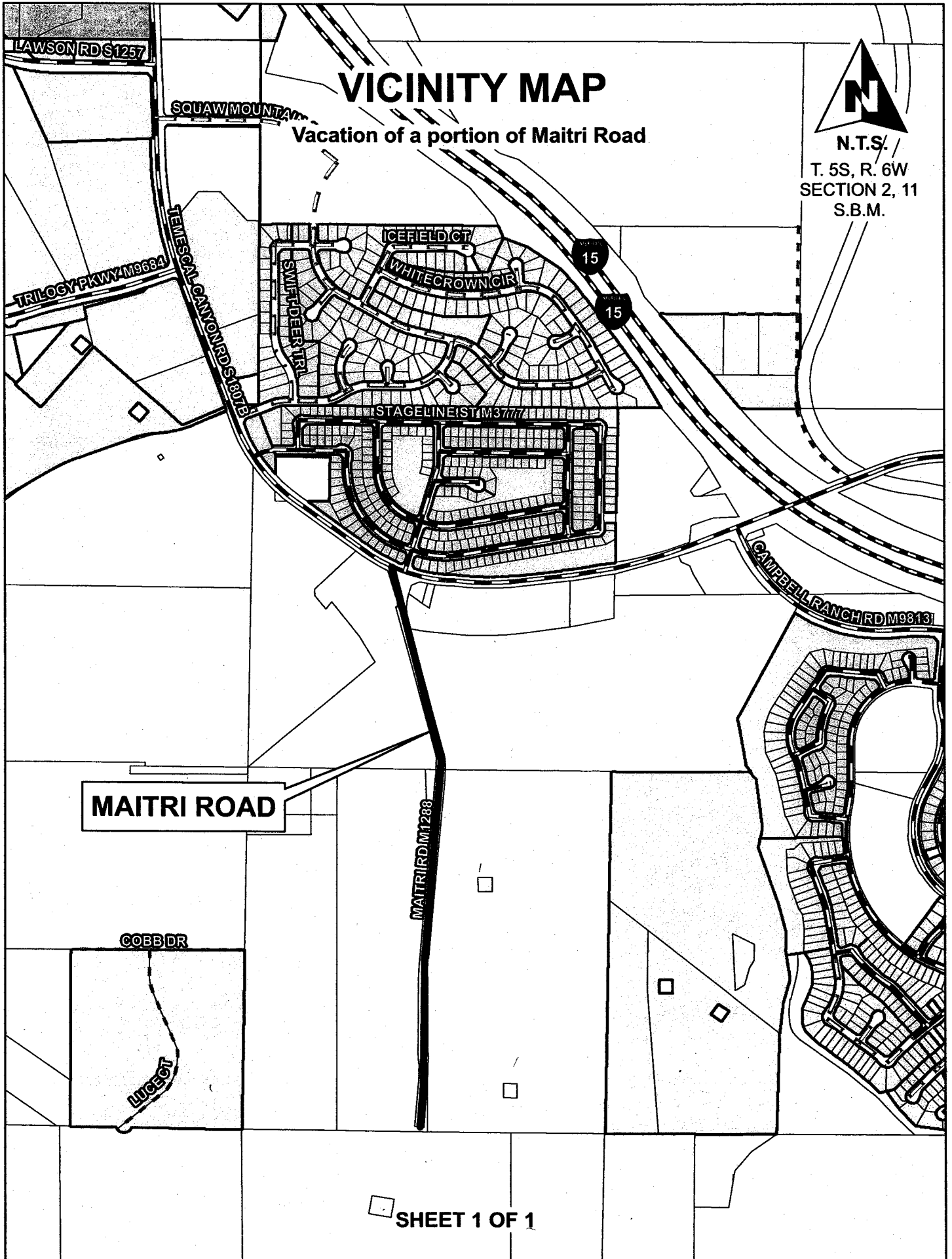
