SUBJECT: Approve the Third Amendment to the Contract with the City of Moreno Valley and the County of Riverside for Vector Control Services.

RECOMMENDED MOTION: That the Board of Supervisors Approve and Direct the Chairman to sign the Third Amendment to the contract between the Department of Environmental Health and the City of Moreno Valley for vector control services, for the period of performance July 1, 2012 through June 30, 2014.

BACKGROUND: This Third Amendment to the contract is necessary due to the need for mosquito and other vector control services within the City of Moreno Valley. Proactive vector control services help to prevent diseases such as West Nile Virus and are imperative to protecting the public's health. This Third Amendment will increase the current contract limits of the City's billable services from \$25,000 to \$32,000 per fiscal year 12/13 and 13/14. Additionally this Third Amendment will extend the contract to June 30, 2014. There are no other changes to the contract.

**THIRD AMENDMENT TO AGREEMENT BETWEEN THE CITY OF MORENO VALLEY
AND THE COUNTY OF RIVERSIDE FOR VECTOR CONTROL SERVICES**

This Amendment to Agreement is made by and between the City of Moreno Valley, California, a municipal corporation, hereinafter referred to as the "City", and the County of Riverside, through its Community Health Agency, Department of Environmental Health, hereinafter referred to as the "Contractor".

RECITALS:

Whereas, the City and Contractor entered into an Agreement entitled "AGREEMENT BETWEEN THE CITY OF MORENO VALLEY AND THE COUNTY OF RIVERSIDE FOR VECTOR CONTROL SERVICES," hereinafter referred to as "Agreement," effective July 1, 2008. (Attachment B)

Whereas the Contractor is providing professional and technical services as more specifically described in the Agreement.

SECTION 1 THIRD AMENDMENT TO ORIGINAL AGREEMENT:

1.1 "Exhibit B, Item C" to the Agreement (Fee Schedule) shall be amended at a rate not to exceed \$32,000 annually for services rendered. (Attachment A)

1.2 "Page 1, Item 3-A, TERMS OF AGREEMENT Contract Term" is hereby amended to extend the term of this Agreement for two additional years beginning July 1, 2012 with a termination date of June 30, 2014.

THIRD AMENDMENT TO AGREEMENT BETWEEN THE CITY OF MORENO VALLEY AND THE COUNTY OF RIVERSIDE FOR VECTOR CONTROL SERVICES

SECTION 2

2.1 Except as otherwise specifically provided in this Amendment, the terms and conditions of the Agreement shall remain in full force and effect.
